## **ARTICLE 1 - AGREEMENT**

- 1.1 The Articles and provisions contained herein constitute a bilateral and binding agreement ("Agreement") by and between the Garden Grove Unified School District ("District") and the Garden Grove Education Association/C.T.A./N.E.A. ("Association") an employee organization.
- 1.2 The Agreement is entered into pursuant to Chapter 10.7, Sections 3540-3549, of the Government Code ("Act").
- 1.3 The Agreement shall remain in full force and effect from July 1, 2023 - June 30, 2024

## **ARTICLE 2 - RECOGNITION**

- 2.1 The District recognizes the Garden Grove Education Association as the exclusive representative as defined in Section 3540.1 (e) of the Government Code. The exclusive representative shall represent that unit of employees as described below.

All certificated employees not excluded by Section 2.2 of this document, who are regular, full-time, permanent, or probationary employees and are in the following positions:

Employees whose assignments are partially in one position and partially in another shall be assigned to the Association's unit of employees if half or more of their assignments is one of the positions listed above.

- 2.3 Both parties to this Agreement must agree on the recognition status (for the purposes of representation) of any newly created position.

**ARTICLE 3 - DEFINITIONS**

- 3.1 Employee - Employee who is included in the appropriate unit as defined in Article 2 and therefore covered by the terms and provisions of this Agreement.
- 3.2 Work Day - A day when schools in the District are in session, excluding Saturdays, Sundays and Summer Session.
- 3.3 School Day - The amount of time each day of classes during which students are required to be in school, unless otherwise provided for in this Agreement.
- 3.4 Immediate Supervisor - The supervising administrator having immediate jurisdiction over the employee.
- 3.5 Board - Board of Education of the Garden Grove Unified School District. It is understood that the Board may discharge its duties by means of authorized officers, representatives, or committees.
- 3.6 School District - The term School District shall refer to the Garden Grove Unified School District.
- 3.7 Association - Garden Grove Education Association, which is affiliated with the California Teachers' Association and the National Education Association.
- 3.8 Association Negotiating Team - Association members chosen to represent the unit in negotiations.
- 3.9 Semester – Approximately one-half of the school year; see calendar for specific dates. (Appendix H)

**ARTICLE 4 - HOURS OF EMPLOYMENT**

- 4.1 Employees shall be required to be at their school site not more than thirty (30) minutes before their instructional time begins and not more than fifteen (15) minutes after their instructional time ends. Employees shall be on site outside of the regular instructional time for additional duties and responsibilities which require a unit member to be at the work site. This includes Back to School Night and Open House. Employees participating in District programs, which require them to be elsewhere may leave after their instructional time ends. Preparation

periods are considered part of the instructional time. Bargaining unit members shall be entitled to a thirty (30) minute minimum, uninterrupted, duty-free lunch break.

4.1a Minimum days may be scheduled for any ESEA and/or School Improvement Plan (AB 65) related meetings that cannot be held within the work time as prescribed by Article 4.1, unless those meetings are held during school purchased released time. Nothing in this article (4.1a) shall be construed to prevent the District from continuing its utilization of minimum days.

4.1b Collaboration – The purpose of collaboration time is for teachers to work together toward the improvement of student achievement. The District and the Association agree that all teachers, TK-12, will collaborate on a regular and ongoing basis. The teachers and administrators will mutually determine the topics for collaboration time. Of the total collaboration meetings, the Principal will determine topics for up to 25% of the meetings based on school-wide needs, with the remainder being mutually determined. Sites shall determine principal collaboration days no later than the first day of each quarter or trimester.

Collaboration Plans may include:

1. Changing the daily instructional minutes as defined in Article 4.5 to bank time for shortened Wednesdays.
2. Utilizing a portion of the minutes as defined in Article 4.1 to bank time for shortened Wednesdays
3. Utilizing a portion of the hours allocated for staff meetings as stated in Article 4.3

4.1c The Collaboration Schedule will be mutually developed by site teachers and administrators. It will be approved by the majority of the teachers at each site via anonymous ballot. The ballots will be counted by the site administrator and one teacher designated by the teachers at the site. The schedule will be submitted by April 1 to the Assistant Superintendent of Elementary Education or Secondary Education for approval. No schedule will be approved that results in a reduction of annual instructional minutes. The site teachers and administrators will review the schedule annually. For schools collaborating weekly, four (4) collaboration days shall be used for individual teacher preparation. The scheduling of the days shall be mutually determined by the administrator and teachers at each school site.

4.2 Adjunct duties are those duties of supervising students for reasons other than instruction.

4.2a Employees shall be involved, through on-site discussions, in the identification and selection of their adjunct duties.

4.2b Adjunct duties shall be assigned by the immediate supervisor in a fair and equitable manner.

4.3 No more than twelve (12) hours of site staff meetings per year, beyond the times stated in Article 4.1, shall be required of an employee.

4.3a Should a site staff meeting become necessary during a school week, it shall normally be scheduled on a Wednesday. Except under emergency situations, employees shall attend scheduled site staff meetings. Under normal circumstances, the administrator who calls such meetings shall provide the employees with a tentative agenda for the meeting one day in advance. No more than one site staff meeting shall be held per day.

4.3b Professional development outside of Article 4.1 and Article 4.3 is voluntary, and shall be compensated in accordance with Article 12.3g.

#### 4.4 Professional Development

4.4a The District and the Association agree that all employees should have equal access to quality professional development to learn new, and to improve current skills and educational strategies. To this end, the District and the Association shall work jointly to provide all employees the opportunity to participate in professional development programs, in accordance with appropriate state law and regulations.

4.4b The District and the Association agree that local school sites are frequently faced with many decisions which are best resolved through group contribution and involvement. Individuals and groups involved in making decisions need to acquire, develop, and practice a variety of skills, including but not limited to: conflict management, problem solving, consensus decision-making, team building, communicating, and managing change.

Therefore, the District and the Association agree to work together to provide professional development and training in the aforementioned skills. Further, the District and the Association agree to consult on the best means to provide such training and to maintain continuing support and assistance to local school sites.

4.5 The instructional time required of employees shall be:

- 4.5a The implementation of a staggered reading program in grades TK through 6 may exceed the instructional time specified in Article 4.5 with mutual agreement of the majority of the affected employees at the school and the school administration.
- 4.5b The annual minutes of instruction for grades 1 through 6 as specified in Article 4.5 may be exceeded to modify the number of parent conferencing days, with the mutual agreement of the majority of the employees affected at the school and the school administration.
- 4.5c All teachers with students in Kindergarten classes including special education classes on a regular schedule shall receive instructional preparation time on one day at the end of the first trimester (one-third of the year) and one day at the end of the first semester (half-year).
- 4.5d All teachers with students in grades TK-6, including special education classes on a regular schedule, shall receive instructional preparation time on one day at the end of the first trimester (one-third of the year), one day at the end of the first semester (half-year), three release days to be scheduled by the Personnel Office, and no less than thirty (30) consecutive minutes per week, excluding the first week of school. Special Education Preschool teachers shall receive instructional preparation time in the form of three (3) release days to be scheduled by the Personnel Office and no less than thirty (30) consecutive minutes per week, excluding the first week of school.
- 4.5e Three IEP Preparation Days shall be provided to TK-6 SDC teachers, M/M and M/S, as well as SDC teachers at Mark Twain for the purposes of preparing for or to hold IEP meetings. Three IEP Preparation Days shall be provided to Special Education Preschool teachers for the purposes of preparing for or to hold IEP meetings.
- 4.5f K-6 teachers who serve both M/M and RS students may choose (1) the 30 minute daily release time with one release day or (2) three release days.
- 4.5g One IEP Preparation Day shall be provided to TK-6 RS teachers for the purposes of preparing for or to hold IEP meetings.
- 4.5h Beginning in the 2018-2019 school year, TK-8 teachers shall be compensated at the rate of \$150 per day in lieu of taking release days. (This provision does not apply to IEP Preparation days). Beginning in the 2022-2023 school year, Preschool Special Education teachers shall be compensated at the rate of \$150 per day in lieu of taking release days (This provision does not apply to IEP Preparation days).
- 4.5i Teachers in grades 7 and 8, including traveling music teachers and Special Day Class teachers, shall receive one release day at the end of the first trimester (one-third of the year), one day at the end of the first semester (half-year), and one day to be scheduled by the Personnel Office.

- 4.5j Teachers in classes in the TK-12 Special School and the Secondary Learning Center shall receive instructional preparation time of one (1) hour per week to be scheduled in no less than two (2) periods of thirty (30) consecutive minutes, excluding the first and last week of school.
- 4.5k Teachers in grades 1-6, in collaboration with their principal, may establish a flexible physical education program which exceeds the class size maximum in Article 9.4. The plan for the flexible physical education program must be submitted to the District for approval prior to implementation.
- 4.5l In recognition of time necessary to coordinate with other personnel, Resource teachers in grades TK-6 that do not have an assigned preparation period shall receive a minimum of 30 minutes, preferably consecutive, of preparation time daily. (All 7-8 Resource and M/M teachers shall receive one prep period daily). (The complete 7-8 prep time shall begin with the 2015-2016 school year).
- 4.5m Secondary M/S teachers, grades 7-12, shall have 30 minutes of weekly preparation time.
- 4.5n Effective August 12, 2024, 9-12 Education Specialists M/M shall be provided one daily Case Management Period for the purpose of providing student support, preparing IEP documents and other required paperwork, and collaborating with staff.
  
- 4.6 The District will allocate funding to provide 50 release days per year (TK-6: 25, and 7-12: 25) for mentor teachers to assist teachers who request help with their Limited English Proficient students.

**ARTICLE 5 - GRIEVANCE PROCEDURES**

5.1 The purpose of this Article is to provide a procedure for the resolution of such problems as may arise involving the interpretation, application, or violation of this Agreement.

5.2 Definitions

5.2a A Grievance is a written allegation that there has been a violation, misinterpretation, or misapplication of this Agreement.

5.2b A Grievant is an employee, or the Association, filing the grievance.

5.2c A Workday, for the purposes of this Article, is a day when schools in the District are in session, excluding Saturdays, Sundays, and Summer Session.

5.3 Protocol

5.3a A grievant may seek to resolve a grievance without intervention by the Association, provided that the resolution is consistent with the terms of this Agreement.

5.3b No grievance shall be resolved before the Association has been given the opportunity to submit a formal response.

5.3c The Association will pursue an employee's grievance only at the employee's request.

5.3d Time limits specified in this Article are maximums unless extended by mutual agreement.

For the purpose of expediting a grievance, the workday (5.2c) shall be converted to a calendar weekday, excluding holidays, under the following circumstances:

The grievance is filed with less than twenty-five (25) workdays remaining in the school session, and;

The grievant requests calendar weekdays.

- 5.3e A grievance must be filed within thirty (30) workdays of the event which gave rise to the grievance.
- 5.3f Forms for filing grievances shall be mutually acceptable to the District and the Association.
- 5.3g The District and the Association agree to conduct these proceedings confidentially and may mutually agree to conduct these proceedings informally.
- 5.3h Grievances involving administrators other than the employee's immediate supervisor, or affecting more than one employee, may be filed directly with the Office of Personnel Services and with the Association.
- 5.3i If the grievant fails to comply with the terms set forth in this procedure, the grievant will be deemed to have waived the right to proceed with the grievance.

#### 5.4 Procedural Steps

- 5.4a Preliminary Level. Before filing a grievance, an employee, the designated Association representative, or both may first discuss the problem informally with the immediate supervisor and/or any other appropriate administrator to attempt an informal resolution.
- 5.4b Level One. A grievance shall first be filed with the immediate supervisor and with the President of the Association on the grievance form. Within ten (10) workdays after the receipt of the grievance, the immediate supervisor shall have met with the grievant and issued a decision in writing.
- 5.4c Level Two. If the immediate supervisor does not comply with the terms of Level One, or the grievant is dissatisfied with the decision, the grievant may, within five (5) workdays, file the grievance with the Office of Personnel Services. Within five (5) workdays after receipt of the grievance, the Assistant Superintendent, Personnel Services, shall have met with the grievant and issued a decision in writing.
- 5.4d Level Three. If the Assistant Superintendent, Personnel Services, does not comply with the terms of Level Two, or the grievant is dissatisfied with the decision, the grievant may, within five (5) workdays, file the grievance with the Office of the Superintendent. Within five (5) workdays after receipt of the grievance, the Superintendent shall have met with the grievant and issued a decision in writing.
- 5.4e Level Four. If the Superintendent does not comply with the terms of Level Three, or the grievant is dissatisfied with the decision, the grievant may, within five (5) workdays, request in writing that the

grievance be submitted to arbitration.

**5.5 Arbitration**

- 5.5a** The District and the Association shall choose a mutually acceptable arbitrator within ten (10) days of the receipt of a written request for arbitration. If no choice has been made after the first five (5) days, they shall request the California Conciliation Service to supply a list of five (5) persons who are experienced in public school arbitration. The District and the Association shall alternately strike a name from the list until only one (1) remains. The order of striking shall be determined by lot.
- 5.5b** Upon the completion of a hearing, the arbitrator shall report findings and awards in writing to the District and to the Association. The award of the arbitrator shall conform to the laws of the State of California and to the terms of this Agreement. Financial awards will be limited to the current fiscal year. In the event that a grievance is filed in September, the past fiscal year may be considered in the final award.
- 5.5c** After receiving the findings and awards from an arbitrator, the Board shall, at its next regularly scheduled meeting, issue a resolution to implement the award. If the Board fails to implement the award of an arbitrator, the grievant may appeal to a court of competent jurisdiction to confirm the arbitrator's award.
- 5.5d** The fees and expenses of the arbitrator and the hearing shall be borne equally by the District and the Association. All other costs will be borne by the party incurring them.

**5.6 Rights of Employees to Representation**

- 5.6a** A grievant may choose to be his/her own representative at any step of the grievance procedure, except arbitration.
- 5.6b** A grievant may choose to be represented at any step of the grievance procedure by the Association or its designee.
- 5.6c** If the grievant is not represented by the Association or its designee, the Association shall have the right to be present and to state its recommendation at any step of the grievance procedure.
- 5.6d** Any employee whose participation is necessary in a grievance proceeding held during the regular school day and who has been designated by the President of the Association, shall be released for that purpose without loss of pay, provided that the employee's immediate supervisor has been notified. The District shall provide and pay for substitutes necessary for this purpose, within the allocated number of days.
- 5.6e** No reprisals of any kind will be taken by the District or any representative of the District against any grievant, any party in

interest, any member of the Association, or any participant in any grievance proceeding, by reason of such participation.

## **ARTICLE 6 – SAFETY**

6.1 Every employee in the public schools shall hold pupils to a strict account for their conduct on the way to and from school, on the play-grounds, or during recess. A teacher, assistant principal, principal, or any other certificated employee of a school district, shall not be subject to criminal prosecution or criminal penalties for the exercise, during the performance of his/her duties, of the same degree of physical control over a pupil that a parent would be legally privileged to exercise but which in no event shall exceed the amount of physical control reasonably necessary to maintain order, protect property, or protect the health and safety of pupils and employees, or to maintain proper and appropriate conditions conducive to learning. (Ed. Code No. 44807)

6.2 An employee shall not be required to engage in any school related activity or assignment which can reasonably be deemed hazardous so that bodily injury might be caused. This includes, but is not limited to, workplace bullying, physical and environmental hazards and student safety. Should the situation involve student health and/or safety, employees may be requested to assist.

6.3 An employee shall report in writing to his/her immediate supervisor any unsafe, hazardous, or potentially dangerous working conditions, including bullying, sexual harassment, site safety. (Board policy 3120: See Admin. Regulation 3120.1. For form, go to GGUSD website, personnel department, form, formal complaints)

The District shall investigate these reported conditions and follow the procedures as outlined in the CAL OSHA (California Occupational Safety and Health Act) regulations. The District shall inform a reporting employee of the resolution of this investigation.

6.4 An employee shall report to his/her immediate supervisor any situation in which a student's conduct threatens the physical or emotional safety of students or employees. The supervisor shall investigate these reported conditions as soon as possible and shall follow appropriate District procedures. If requested, the employee shall be provided with all relevant and appropriate information regarding the findings of such investigations.

6.5 Employees at each duty site shall be involved in the development of written school related safety procedures and policies through the existing on-site CAL OSHA Safety Committee.

6.6 In accordance with ed code 49079, Garden Grove Unified School District shall notify the teachers of a current student of all suspected offenses listed in ed code 49079, which may have occurred in the past three years. This notification shall include all records that are kept by the school or district related to each incident or narrative based on those records.

6.7 The District and the Association agree that health and safety is an increasing concern to school employees. To this end, the District and the Association shall work jointly to assist each school health and safety committee in

developing school-wide health and safety procedures.

- 6.8 The District and the Association shall work jointly on a District-wide Safety Committee.

## **ARTICLE 7 - EVALUATION PROCEDURES**

### **7.1 Purpose**

The District and the Association believe that a formal, consistent evaluation system is accurate, authentic, fair, meaningful, and streamlined as an important way to assess and improve employee performance and, therefore, the quality of instruction offered to pupils. In accordance with the Education Code Sections 44660-44664, the performance of each employee within the bargaining unit shall be evaluated in writing by an administrator in the following areas: (1) Progress of pupils toward standards established by School Board grade level expectancies, course outlines, etc.; (2) Instructional techniques and strategies; (3) Adherence to curricular objectives; (4) Establishing and maintaining a suitable learning environment within the scope of the employee's responsibilities; and (5) Job responsibilities. All evaluations shall be written on standard district forms. (See Appendix for forms.)

### **7.2 Definitions**

7.2a A scheduled observation shall last a minimum of 30 minutes. Scheduled observations shall be arranged by the evaluator and employee at least 2 (two) instructional days in advance of the scheduled observation. A change in the scheduled observation date may be requested by either the employee or evaluator, if necessary. Either the employee or the evaluator may request a pre-observation conference to discuss the lesson which will be the subject of the observation.

7.2b An unscheduled observation shall last a minimum of 15 minutes.

### **7.3 Frequency**

Permanent employees shall be evaluated at least every 5 years for teachers with more than 10 full years teaching in the district and at least biennially for teachers with 3 to 10 years in the district. Non-permanent employees (temporary and probationary) shall be evaluated annually. All evaluations shall be completed no later than May 1.

### **7.4 Observations**

7.4a The evaluator shall base the employee's evaluation on information gathered through unscheduled and/or scheduled observations, conferences, job descriptions, and first hand knowledge of total performance. The Evaluator shall provide feedback on observations, commendations and/or recommendations in areas needing improvement.

7.4b Non-permanent Employees

Non-permanent Employees shall have at least one scheduled observation and a minimum of two (2) unscheduled observations each year.

**7.4c Permanent Employees**

Permanent employees shall be observed using either a minimum of two (2) unscheduled observations or a minimum of one scheduled observation. The employee decision shall be indicated on the Evaluation Procedure Form and submitted to the Administration by October 1.

**7.4d Observation Conferences**

Within 5 days after an observation (unscheduled or scheduled) the employee shall be given a copy of the Observation Report. A conference shall be held within 10 workdays of the observation.

**7.4e Observation Deadline**

The first observation shall occur on or before December 10.

**7.5 Recommended Improvements**

**7.5a** The area(s) needing improvement shall be noted by the evaluator as soon as they are identified. Both employee and evaluator shall take appropriate action to correct deficiencies. If circumstances warrant, such action should include:

- Specific recommendations by the evaluator
- Opportunities to observe other teachers
- Resources/assistance to be provided by the evaluator
- Assistance from District resources identified by the evaluator
- Inservice/staff development training recommended by the evaluator

If subsequent corrective action does eliminate the deficiencies, such improvement shall be properly noted as soon as possible in an appropriate addendum to the employee's file.

7.5b Should area(s) needing improvement continue to be unsatisfactory, the employee shall receive a Recommended Improvements Form which shall include a specific plan for correction, a recommended timeline for action, and follow-up by the evaluator. Such recommendation shall be based on at least two (2) observations and/or conferences. Employees shall receive reports no later than March 15 in order to afford reasonable time and opportunity to improve performance.

## 7.6 Final Evaluation

7.6a No later than May 1, an evaluation conference shall be held during which time the evaluator and employee shall review the evaluation in order to discuss its final wording. Deficiencies may not be cited in the written evaluation unless previously indicated to the employee and he/she has been allowed reasonable time for correction. The Evaluation Summary shall reflect progress or lack thereof in the areas identified under Section 7.1 and 7.5a. In accordance with Education Code, should the evaluation be unsatisfactory, the employee shall be placed in the Peer Assistance and Review Program (PAR) and shall be evaluated each year until the evaluation is once again satisfactory.

7.6b A written summary of the evaluation shall be signed by both parties. The signature of the employee shall indicate receipt of the document, not necessarily agreement therewith. The employee shall receive a copy of the written summary no later than May 15 of the evaluation year.

## 7.7 Response

An employee has the right to attach a response to any written evaluation using the Employee Response Form.

## 7.8 Personnel Files

7.8a Evaluative data shall not include allegations by anyone, unless the allegations have been investigated and confirmed as fact by the District.

7.8b Each employee shall be given a copy of each entry into his/her personnel file, signed and dated by the evaluator. Entries should be made within five (5) days of the employer's knowledge of the incident.

7.8c The District shall maintain employees' files at the District Office only.

7.8d Any files kept by an employee's immediate supervisor shall contain only the current evaluative data and those materials found in the District Office file.

**ARTICLE 8 – PEER ASSISTANCE AND REVIEW PROGRAM (PAR)**

**8.1 Purpose**

The Garden Grove Education Association and the Garden Grove Unified School District agree to implement the California Peer Assistance and Review (PAR) Program as a critical feedback mechanism that allows exemplary teachers to assist teachers in need of development in subject matter knowledge, teaching strategies, classroom management, or in all three areas. This Program provides assistance to teachers in order to improve the teaching and learning process.

**8.2 Participating Teacher**

A Participating Teacher shall be a unit member with permanent status who is referred or volunteers to receive assistance and coaching to improve instructional skills, classroom management, knowledge of subject matter or in all three areas.

**8.2a Referred Participating Teacher**

The Referred Participating Teacher shall be required to participate in PAR for a minimum of one (1) year as a result of an unsatisfactory final evaluation in any of the above mentioned three (3) areas. A Referred Teacher shall participate in both assistance and review. The Referred Teacher shall be assigned a Consulting Teacher by the Joint Panel. The Consulting Teacher, Referred Teacher and the site administrator shall meet to discuss the Peer Assistance and Review Program, and to establish mutually agreed upon performance goals with respect to the process of Peer Assistance and Review. The Consulting Teacher will provide assistance to the Referred Teacher until the Consulting Teacher concludes and reports to the Joint Panel that his/her performance goals have been achieved, or that further assistance will not be productive. Annually, the Consulting Teacher will submit a final report to the Joint Panel. The Consulting Teacher shall continue to provide assistance until the Joint Panel acts on the recommendation.

The Referred Teacher shall have the right to submit a request, in writing, to the Joint Panel for a different Consulting Teacher. He/she will state the reasons why the Consulting Teacher should be replaced and have those reasons considered. The Referred Teacher shall also have the right to submit a written response to the Consulting Teacher's final report within ten (10) working days. The Referred Teacher may address the Joint Panel for up to five (5) minutes regarding the final report. A designee of the Association may accompany the Referred Teacher to this meeting.

**8.2b Volunteer Participating Teacher**

A Volunteer Participant may request the Joint Panel to assign a Consulting Teacher to provide peer assistance. The Consulting Teacher shall play no role

in the evaluation of the teaching performance of the Volunteer Participant. The Volunteer Participant shall indicate area(s) in which he/she seeks assistance in his/her request (ex. new grade level, new subject area, etc.). The Volunteer Participant may terminate his/her participation in the PAR program at any time without the requirement to give a reason for said request. All communication between the Consulting Teacher and a Volunteer Participant shall be confidential; and without the written consent of the Volunteer Participant, shall not be shared with others, including the site principal, the evaluator, or the Joint Panel.

**8.3 Consulting Teacher**

A Consulting Teacher shall be a permanent certificated unit member, selected by the Joint Panel, who provides assistance to Participating Teachers.

**8.4 Joint Panel Committee**

The Joint Panel will supervise and evaluate the PAR program and shall consist of seven (7) members composed of four (4) permanent certificated classroom teachers selected by the Association, and three (3) administrators selected by the District.

**8.5 Special Provisions**

**8.5a Confidentiality**

All materials related to evaluations, reports, deliberations and other personnel matters shall be confidential, subject to the following exceptions:

- a) In response to subpoena or order of the court;
- b) The final report of a Referred Teacher's participation in the program shall be made available for placement in his/her personnel file;
- c) The final report may be used by the District in any employment action based upon instructional performance.

**8.5b Duty to Indemnify**

The District shall hold harmless the members of the Joint Panel and Consulting Teachers for any or all liability arising out of their participation in the PAR Program.

**8.5c Duties and Responsibilities**

Duties performed pursuant to this article by bargaining unit members shall not constitute either management or supervisory functions.

**ARTICLE 9 - CLASS SIZE**

**9.1 Commencing in 2017-2018, it is agreed that the District staffing ratio for regular classroom teachers shall be:**

TK-3	25:1	2017-2018
	24.5:1	2018-2019
	24:1	2019-2020

Grades 4-12                      29:1

9.2                      Assignment of special education teachers shall comply with existing State regulations.

In the event that a waiver application for an increase in the size of a special education class becomes necessary, the teacher of that class shall be consulted by the District and his/her response shall be recorded on that application.

9.3                      Staffing adjustments necessary to meet the above ratios shall be made following the October Report and prior to October 1. When the District-wide staffing indicates a deficiency of .50 of a teacher, an additional teacher shall be employed.

9.4                      The number of students enrolled per class shall not exceed the maximums listed below:

TK-3 and 3/4 combinations	34
4-6	36
7-8	36 except physical education and performing music

At any time that a class size maximum is exceeded in any area other than PE and performing music at the 7-8 level, the teacher may request that the principal reduce the class size to the specified maximum. The principal shall make arrangements to comply within ten (10) teaching days in those instances where there is clear evidence of sufficient classrooms, minimum need of temporary classrooms and when there is no need to change boundaries or use busing.

In addition to the teachers provided under Article 9.1, the District shall provide forty-nine (49) teachers in grades 9-12 in order to reduce average class size. Each comprehensive high school shall receive seven (7) additional teachers.

9.5                      The number of students in an educational specialist caseload shall not exceed 28 students (as per provisions of Ed Code)

9.6                      There will be a 15:1 hard cap for the Special Education Preschool classes. At any time that a class size maximum of fifteen (15) in Special Education Preschool is exceeded, the teacher may request that the District reduce the class size to the specified maximum. The District shall make arrangements to comply within ten (10) teaching days.

#### **ARTICLE 10 - TRANSFER PROCEDURES**

10.1                     A vacancy as related to this section is defined as a unit of teacher entitlement to which no employee has been assigned.

10.2                     A transfer is defined as a change of school assignment from one site to another.

- 10.3 Transfer requests may be granted at any time, subject to the availability of positions and the qualifications of the applicants.
- 10.4 Notices of vacant positions shall be posted in all work locations, the Association Office, the Office of Personnel Services, and the GGUSD Website when an opening occurs and shall remain posted six (6) workdays. Key posting dates shall happen on the first Friday of every month by 5pm. If the first Friday falls during the winter recess, spring recess or on the 4th of July holiday, the posting shall occur the following Friday. Additional postings shall occur as needed with approval from the Association.
- (Such notification shall be sent electronically to all employees, dated and posted at each work site, Office of Personnel Services, the GGUSD website and the Association Office.)
- 10.5 Notices shall include the position, description and location, level, or subject matter assignment, and credential requirements.
- 10.6 In the event of an emergency, the opening may be filled on a temporary basis pending the selection of a permanent replacement.
- 10.7 Employees wishing to apply for the vacancy must file an application with the Office of Personnel Services within six (6) workdays of the date of posting. By the end of the six (6) additional workdays, the employee shall be notified of a time and place of interview for each vacancy for which he/she has been considered. Whenever possible, a teacher will be included in the interview. Those not interviewed shall be notified in writing with the reason stated. Within ten (10) days after the position has been filled, every employee who applied will be notified in writing of the decision. (open only to probationary and permanent employees)
- 10.8 Transfer requests may be withdrawn upon written notification to the Office of Personnel Services. Upon notification of selection, an employee shall be assigned to that position unless the employee submits a written rejection to the Office of Personnel Services within two (2) workdays.
- 10.9 Should a reduction in the number of employees in a school become necessary, the reduction may be accomplished by an employee requesting to be classified as an involuntary transfer from the school.
- 10.10 Should involuntary transfer(s) become necessary, length of service teaching in the District, experience, credential, and major and minor fields of study shall be determining factors as to which teacher(s) shall be transferred. The employee to be transferred can choose to apply for a vacant position, or choose to be placed in a vacant position for which he/she is qualified. Under normal circumstances, the employee with the least service in the District shall be transferred first, except when an entire program is moved to a new site (for example, GATE program and specific Special Education programs).
- 10.11 A written notice of involuntary transfers will be made as soon as possible, and no later than the 1<sup>st</sup> Monday in May, to the employees being considered for transfer.

- 10.12 Teachers transferred after school begins shall be provided with two days of released time to be utilized for the conclusion of the present assignment and in preparation for the new assignment. The need for additional days beyond two shall be determined by the District. The District shall be responsible for the move of all District property.
- 10.13 Should a determination be made by the Superintendent or his/her designee, that a transfer is necessary for reasonable cause at any time, such transfer may be made following a conference with the employee.
- 10.14 An employee who is involuntarily transferred because of declining enrollment has the opportunity to return to his/her site or eligible position if it becomes vacant prior to October 1. The employee shall have the right to return if a position becomes open during the following school year.
- 10.15 In the event that a Consulting Teacher is placed on assignment for up to one year, said Consulting Teacher shall have the right to return to his/her previous work site upon the conclusion of his/her assignment.
- 10.16 Following a resolution by the District that a school shall be closed and the students are to be assigned to other schools, the employees of the closing school shall be assigned, after consulting with the immediate supervisor, to one of the schools receiving students. The Office of Personnel Services shall notify employees so assigned prior to April 15. All regular transfer procedures shall be available to employees affected by school closings.
- 10.17 Special Education teachers shall receive five (5) days prior notice when their assignment is changed.
- 10.18 When the District reassigns an employee to the bargaining unit, the site assignment of that employee shall be determined with equal consideration as other employees.
- 10.19 Following a resolution by the District that a school shall open/re-open and students shall be transferred from other schools to the newly opened/re-opened school, employees from any school(s) affected by the decision shall be granted first opportunity to be interviewed for vacancies at the newly opened/re-opened school, based on length of service in the District, experience, credential, and major and minor fields of study. After these interviews, if vacancies still exist, the vacancies shall be subject to the provisions of Article 10.
- 10.20 In order to allow teachers to make informed decisions regarding the use of this Article, principals shall provide each teacher with his or her tentative teaching assignment prior to the first Monday in May, other than in exceptional circumstances.

## **ARTICLE 11 - LEAVES**

### **11.1 Notification Procedure**

- 11.1a Employees shall notify the District in advance of any leave. In case of emergency leave, employees who find it necessary to be absent

from duty shall notify the District Office on the first day of their emergency leave before 7:00 a.m. of the day of absence. Employees who are absent from duty on the second or subsequent days shall notify the school daily before 1:00 p.m. to indicate that they will not return to duty on the following day. In the case of known absences of more than one day, arrangements should be made with the principal of the school site to eliminate the daily call.

## 11.2 Illness or Injury Leave

- 11.2a Every employee who is regularly employed five (5) days per week is entitled to ten (10) days paid sick leave for that year of employment. Employees who work less than full time shall be entitled to a proportionate amount of sick leave in accordance with the contract. The ten (10) days per school year may be accumulated without limitation.
- 11.2b When the certificated employee is absent from his/her duties due to illness or injury for a period of more than ten (10) days, the employee shall supply the site supervisor with a statement from a qualified medical doctor verifying the employee's illness or injury.
- 11.2c The District may require verification by a physician of an employee's ability to perform his/her responsibilities before returning to work due to an absence in excess of ten (10) days for illness or disability injury.
- 11.2d Unused sick leave shall accrue from school year to school year.
- 11.2e The Board shall provide each employee with a written statement of (1) his/her accrued sick leave total, and (2) his/her sick leave entitlement for the school year. An employee may use his/her credited sick leave at any time during the school year.
- 11.2f During the length of this contract, when a certificated employee is on an illness or injury leave, he/she shall be paid full salary for that period of time equal to the balance of his/her accumulated illness leave.

Beginning January 1, 1999, employees in the bargaining unit whose illness/injury benefits have been consumed and must still be absent from duty because of illness or injury shall receive that amount of pay which is the difference between their pay and the amount paid for a substitute employee, whether or not a substitute is employed, for a total of 100 days commencing with the exhaustion of their accumulated sick leave.

## 11.3 Personal Necessity Leave

- 11.3a Employees shall be allowed not more than ten (10) days of accumulated sick leave annually for the purposes of personal necessity. Any of the ten (10) days may be used for reasons of compelling personal importance. (However, in no case shall this

leave be used for vacation purposes.)

- 11.3b The employee shall notify his/her principal at least seventy-two (72) hours in advance of taking such leave, unless an emergency makes such notice impossible.
- 11.3c Under all circumstances, an employee shall verify by signature that the personal necessity leave taken was in compliance with this Article.

#### 11.4 Family Illness Leave

- 11.4a Three (3) days of leave per year without loss of salary or sick leave shall be allowed to any employee for an illness, which is of a serious nature, of a member of the employee's immediate family. An illness of a serious nature shall be an illness which an employee cannot reasonably be expected to disregard and which requires the attention of the employee during his/her assigned hours of service. An employee may use three (3) additional family illness days, but the additional three (3) days will be deducted from his/her sick leave.

#### 11.5 Pregnancy Disability/Maternity Leave

- 11.5a **Pregnancy Disability Leave**  
Employees are entitled to use accumulated sick leave as set forth in the provisions of illness/injury leave, for disabilities caused or contributed to by pregnancy, miscarriage, childbirth, or recovery therefrom. Such leave shall not be used for child care, but shall be limited to those disabilities as set forth above. The length of such disability leave, including the date upon which the leave shall commence and the date on which the duties are to be resumed, shall be determined by the employee and the employee's physician.
- 11.5b In cases of miscarriage, an individual on pregnancy/disability leave may be considered for immediate placement provided a position for which the individual is qualified exists and a statement from the attending physician indicates that the employee is able to assume full responsibilities of the position without detriment to her health.
- 11.5c **Maternity Leave**  
An employee is entitled to a leave of absence without pay for a period of up to one year because of pregnancy, miscarriage, childbirth, and recovery therefrom. Employees on a District approved maternity leave shall continue to receive full health and welfare benefits paid by the District for six (6) months from the first day of the month following the last day worked. The date upon which the leave shall commence and the date upon which duties are to be resumed shall be determined by the employee and the employee's physician. The leave request shall be submitted to the District not less than twenty (20) days prior to the commencement of the leave, when possible.

**11.6 Parental Leave**

**11.6a Purpose**

Employees who have been employed for at least 12 (twelve) months on a part-time or full-time basis, are entitled to a parental leave for a total of up to 12 work weeks (60 work days) in one year (12 months) period as set forth in state law, EC 44977.5 for the following reasons: bonding within the first year as a result of the birth, adoption or fostering of a child.

**11.6b Definitions**

Employees: mother, father, adoptive parent, foster parent

**11.6c Procedure**

The leave request shall be submitted to the District not less than thirty (30) calendar days prior to the commencement of the leave, whenever possible. Verification of the birth, adoption or foster shall be provided to the district.

The leave may be used on an intermittent basis with duration of no less than two week increments. However, the District must grant a request for a leave of less than two weeks' duration on any two occasions. All parental leave must conclude one year or 12 months from the birth, adoption or fostering of a child.

Parental leave runs concurrently with CFRA baby bonding leave and any other sick leave taken during a period of parental leave.

**11.6d Concurrent Use of Paid Leave**

When an employee is on a parental leave due to the birth, adoption or fostering of a child, he/she shall be paid full salary for the period of time equal to the balance of his/her accumulated sick leave. Once sick leave is exhausted, the employee will receive differential pay, meaning he/she is paid the difference between his/her rate of pay and the cost of a substitute (whether or not a substitute is actually employed).

**11.6e Benefits Continuation**

The District shall maintain the qualified employee's coverage under medical, dental, vision, and life insurance benefits during the period of the leave. STRS service credits may be purchased by the employee for the period of the parental leave in accordance with STRS regulations.

**11.6f Both Parents Taking Parental Leave**

When spouses are both employed by the District, the parental leave is limited to an aggregate of 12 work weeks if such leave is taken for the birth/adoption/foster care of a child.

## 11.7 Family Care Leave

### 11.7a Purpose

All eligible employees are entitled to a family care leave for a total of up to 12 work weeks (60 work days) in any school year as set forth in state (California Family Rights Act) and federal (Family and Medical Leave Act) statutes for the following reasons: (1) for the care of the employee's son/daughter (birth/adoption/foster care); (2) for the care of the employee's spouse, domestic partner, son/daughter, or parent who has a serious health condition; (3) for a serious health condition that makes the employee unable to perform the job duties.

### 11.7b Definitions - For the purposes of this provision:

**Eligible Employee:** Must have worked for the District for at least 1250-hours, which includes paid leave and/or family care leave, during the previous school year. Full-time employees meet the 1250-hour requirement.

**Spouse:** Legal husband, wife, or domestic partner of the employee.

**Son or Daughter:** Biological, adopted, foster, step-child, legal ward, or a child of a person standing in loco parentis, who is under 18 years of age, or 18 years of age or older and incapable of self-care because of mental/physical disability.

**Parent:** Biological parent of an employee or an individual who stood in loco parentis to the employee when the employee was a son or daughter.

**Serious Health Condition:** An illness, injury, impairment, or physical or mental condition that involves inpatient care in a hospital, hospice, or residential medical care facility; or continuing treatment by a health care provider.

### 11.7c Procedure

The leave request shall be submitted to the District not less than thirty (30) calendar days prior to the commencement of the leave, when possible. Medical certification for serious health-related leaves shall state:

1. The date on which the serious health condition began.
2. The probable duration of the condition.
3. The appropriate medical facts regarding the condition, including the need for the leave.

### 11.7d Benefits Continuation

The District shall maintain the employee's coverage under medical,

dental, vision, and life insurance benefits during the period of the leave. STRS service credits may be purchased by the employee for the period of the family care leave in accordance with STRS regulations.

If the employee fails to return to work, the District may recover its share of the insurance premiums paid during the period of unpaid leave unless the failure to return is caused by a serious health condition of the employee or other circumstances beyond the employee's control.

#### 11.7e Special Provisions

##### Concurrent Use of Paid Leave

When an employee is on a family care leave due to the serious health condition of the employee's spouse, domestic partner, son, daughter, or parent, he/she shall be paid full salary for the period of time equal to the balance of his/her family illness and accumulated sick leave. When an employee is on a family care leave due to the birth/adoption/foster care of the employee's son/daughter, he/she shall be paid full salary for that period of time equal to the balance of his/her family illness and personal necessity leaves.

##### Pregnancy/Disability Leave

At the conclusion of a pregnancy/disability leave, an employee may elect to take family care leave.

##### Both Parents Taking Family Care Leave

When spouses are both employed by the District, the family care leave is limited to an aggregate of 12 work weeks if such leave is taken for the birth/adoption/foster care of a son or daughter.

#### 11.8 Military Leave

- 11.8a Employees who are members of any reserve corps of the Armed Forces of the United States, the National Guard, or the Naval Militia, or who are inducted or who are otherwise ordered to active duty, shall be granted such leave as required by the Education and Military and Veterans Codes. A copy of military orders shall be provided to the District Office with the request for military leave. In accordance with education code and military code 395(c), military personnel shall receive their full salary and benefits upon completion of their active duty and shall be reinstated to their position within six months. Reinstatement rights as stated in 11.15 do not apply; within six months a teacher will be returned to his/her position.

#### 11.9 Bereavement Leave

- 11.9a Upon the death of a member of the immediate family, absence without loss of salary or sick leave shall be allowed to any regular

employee for a period of not to exceed three (3) days or five (5) days leave of absence if travel beyond a 300 mile radius is required.

- 11.9b "Immediate family," for the purposes of this provision, shall be defined as mother, father, child, grandmother, grandfather, or grandchild of the employee or the spouse of the employee, and the spouse, domestic partner, son-in-law, daughter-in-law, brother, or sister of the employee, or any relative living permanently in the immediate household of the employee.

#### 11.10 Jury Duty/Witness Leave

- 11.10a Leaves of absence for jury duty shall be provided at a salary which is equal to the difference of the employee's regular earnings and any amount he/she receives as a juror's fee during the period he/she serves on the jury.
- 11.10b Leave of absence shall be granted an employee when he/she has been served a subpoena to appear as a witness, not as a litigant, in a court case. The length of the leave granted shall be for the number of days in attendance in court as certified by the clerk or other authorized officer of the court. The employee shall receive full pay during the leave period, provided that the witness fee for such leave, with the exception of travel allowance, is assigned to, and the subpoena and court certification are filed with, the School District.
- 11.10c Employees who voluntarily postpone their jury duty service to a school vacation period shall be compensated at the current substitute teacher rate for each day's service.

#### 11.11 Health and Hardship Leave

- 11.11a The Board of Education may grant a leave of not more than one (1) school year to an employee unable to perform duties due to ill health, physical disability, or personal hardship, at the request of the employee. Verification of illness or physical disability, by a licensed physician, shall be required. Requests for personal hardship leaves shall be processed through the Office of Personnel Services.

#### 11.12 Long Term Leave

- 11.12a The Board of Education may, upon written application by an employee, grant a leave of absence without pay for not less than one semester nor more than a year for purposes such as, but not limited to, child care or obtaining newly mandated State credentials required for maintaining current position or responsibility.
- 11.12b During any school year in which the Board of Education does not grant sabbatical leaves in accordance with Section 11.14, the Board shall grant up to twenty (20) one-year leaves of absence without pay for reasons not specified elsewhere in Article 11 unless a credentialed replacement cannot be found. Requests must be submitted to the Office of Personnel Services by the first Monday in

April for a leave starting the following school year.

When more than twenty (20) employees apply, the twenty (20) leaves shall be granted according to length of service in the District.

Employees may not receive more than one (1) unpaid leave as specified in Section 11.12b in any seven (7) year period. Employees shall be notified of approval or denial of their leave request prior to the second Monday in May.

**11.13 Industrial Accident and Illness Leave**

11.13a Employees will be entitled to an industrial accident leave for an injury which qualifies for compensation benefits in accordance with requirements of the Education Code and the provisions of the California Workers Compensation Law.

11.13b Such leave shall not exceed sixty (60) days during which the schools of the District are required to be in session, or when the employee would otherwise be performing work for the District. When an industrial accident or illness leave overlaps into the next fiscal year, the employee shall be entitled to only the amount of unused leave due him/her for the same illness or injury.

11.13c The District has the right to have the employee examined by a physician designated by the District, to assist in determining the length of time during which he/she will be temporarily unable to perform assigned duties and/or the degree to which the disability is attributable to the injury involved.

11.13d For any days of absence from duty as a result of the industrial accident, the employee shall endorse to the District any wage loss benefit check from the adjusting firm or carrier which makes the total compensation from both sources exceed 100% of the amount the employee would have received as salary or Workers Compensation benefit. If the employee fails to endorse to the District any wage loss disability check received because of the industrial accident or illness as provided above, the District shall deduct from the employee's salary warrant the amount of such disability indemnity actually paid to and retained by the employee.

**11.14 Sabbatical Leave**

11.14a After completing seven (7) consecutive full school years of service, an employee will be eligible to apply for leaves of one semester or one year duration for the purpose of academic study or travel. Applicants for sabbatical leave must submit their request to the Personnel Office no later than September 30 for a leave starting the following school semester or school year. If a split sabbatical leave is desired it must be requested at the time of application of the first semester of such leave. Employees shall be notified of approval or denial of sabbatical leave requests within thirty (30) days and shall receive the reason for denial, in writing, if requested.

11.14b The Superintendent may recommend approval of sabbatical leave requests to the Board of Education, and the Board of Education may grant such leave.

11.14c An employee on sabbatical leave for one semester shall receive full salary and full health and welfare benefits. An employee who is on a full year's sabbatical shall receive fifty (50) percent of his/her salary and full health and welfare benefits. Paid sick leave is not earned while on sabbatical leave. The District is freed from any liability for the payment of any compensation or damages provided by law, for the death or injury of the employee while he/she is on sabbatical leave. All sabbatical leaves shall be administered in accordance with Education Code 44966-44975.

11.14d The terms and conditions of the leave shall be agreed upon in writing and shall include, but not be limited to:

An indemnification bond equal to twice the salary received during the sabbatical leave;

A requirement of service to the District of two (2) full years for each full year of leave, and one full year for each one-half year of leave; and

Appropriate reporting procedures on the values of sabbatical leave as may be designated by the Superintendent.

## 11.15 Catastrophic Leave

### 11.15a Definitions

A "catastrophic illness or injury" shall be defined as an injury or illness that is expected to incapacitate the employee for an extended period of time, causing the employee to miss ten or more days from work, which would create a financial hardship for the individual because they have exhausted all of their accumulated sick leave.

11.15b The following shall not be eligible for use of Catastrophic Leave:

- Conditions or illness resulting from the commission of a crime
- Elective cosmetic surgery
- Any mental stress related illness, unless the employee is hospitalized
- Illnesses/injury covered under the Workers' Compensation Program

11.15c A "day of catastrophic leave" shall be defined as the amount of dollars necessary to augment the Bargaining Unit Member's differential pay in order that the Bargaining Unit Member shall receive one hundred percent (100%) of their per diem base salary while using Catastrophic Leave. No Bargaining Unit Member shall receive more than 100% of

their base salary, including contributions from other sources, while using Catastrophic Leave.

- 11.15d A Catastrophic Leave Committee (CLC), comprised of two (2) GGEA members appointed by the GGEA President and two (2) District representatives shall administrate the Catastrophic Leave Bank (CLB). Decisions to approve the use of Catastrophic Leave shall be made only by majority vote of the CLC (i.e. three members constitutes a majority of the four-person committee). A 2-2 vote of the CLC shall result in the denial of the request for a CLB withdrawal.
- 11.15e Decisions of the Catastrophic Leave Committee shall be final and are not subject to the grievance procedure contained in Article 5 of this agreement.
- 11.15f Participation shall be voluntary but shall require a contribution of one (1) irrevocable day of accumulated sick leave to the CLB; only contributors shall be permitted to request a withdrawal from the CLB.
- 11.15g All bargaining Unit Members shall be eligible to contribute to the CLB by September 30<sup>th</sup> provided that the Bargaining Unit Member shall have a minimum of five (5) days of earned sick leave remaining after contributing a sick leave day to the CLB.
- 11.15h Bargaining Unit Members hired after the first day of the student instructional year shall be eligible to contribute to the CLB during the first (30) calendar days of employment, provided that the Bargaining Unit Member shall have a minimum of five (5) days of earned sick leave remaining after contributing a sick leave day to the CLB.
- 11.15i GGUSD shall make Catastrophic Leave Enrollment forms available to all Bargaining Unit Members. Members will only need to complete the enrollment form once in their GGUSD career.  
  
If a member enrolls in the CLB and, in a following year, does not have the minimum number of days available at the time of donation, their participation in the CLB will be automatically terminated. They may select to re-enroll in the following year, or any year after, by submitting a new enrollment form during the open enrollment period.
- 11.15j Contribution forms shall be received by the Office of Personnel Services no later than the September 30<sup>th</sup> or no later than the thirtieth (30<sup>th</sup>) calendar day of the Bargaining Unit Member's employment, if hired after the first student instructional day of the work year.
- 11.15k Days shall be contributed to and withdrawn from the CLB without regard to the daily rate of pay of the CLB participant.

- 11.15l Days contributed to the CLB shall be a general contribution, not made for a specific member.
- 11.15m Days in the CLB shall accumulate from year to year.
- 11.15n Each day donated to the CLB shall equate to one (1) day of catastrophic leave.
- 11.15o Upon initial contribution to the CLB, no further contribution that year shall be required from participants unless the number of days in the CLB drops below sixty (60).
- 11.15p In the event that the number of days in the CLB drops below sixty (60), the Committee shall send out notification to all Bargaining Unit Members that they must contribute an additional irrevocable day to remain a participant in the CLB.
- 11.15q In the event that 11.15p occurs, there will be an opportunity for initial contributions to be made by interested Bargaining Unit Members.
- 11.15r Catastrophic Leave participants shall use all of their sick leave, before being eligible to withdraw from the CLB.
- 11.15s Bargaining Unit Members who have disability and/or income protection insurance shall apply for that benefit(s) before applying to use the CLB.
- 11.15t Bargaining Unit Members shall not be eligible to use Catastrophic Leave unless the total benefit(s) plus differential pay results in less than 100% of the Bargaining Unit Member's per diem base salary.
- 11.15u Utilization of Catastrophic Leave, when combined with differential pay and disability or income protection benefits, shall not result in income greater than the Bargaining Unit Member's per diem base salary.
- 11.15v If the participant is incapacitated to the point of being incapable of completing an application, applications may be submitted to the Catastrophic Leave Committee by the participant's agent or member of the Bargaining Unit Member's Family.
- 11.15w Withdrawals from the CLB shall be granted in units of no more than twenty (20) Bargaining Unit Member work days. Bargaining Unit Members may submit a request for two extensions of up to twenty (20) additional days each. Withdrawal from the CLB shall be limited to a maximum of sixty (60) days within a school year per eligible Bargaining Unit Member.
- 11.15x Bargaining Unit Members may use approved days from the CLB intermittently in order to receive and recover from therapies and/or

treatments directly related to the illness or injury for which the withdrawal from the CLB is originally approved.

- 11.15y Any days approved that are unused by the Bargaining Unit Member shall be returned to the CLB at the end of the school year.
- 11.15z If more than one (1) applicant requests use of Catastrophic Leave at the same time and the number of days in the CLB is not adequate to fulfill the total number of days requested, the number of days shall be divided equally among the applicants until such time as there are enough days to fulfill the requests.
- 11.15aa The use of Catastrophic Leave shall run concurrently with the Health and Hardship leave identified in Article 11 of the Agreement between the Association and the District.
- 11.15bb Bargaining Unit members wishing to use this CLB shall submit a "Catastrophic Leave – Request for Withdrawal Form" to the Office of Personnel Services. Bargaining Unit Members applying to utilize days of Catastrophic Leave shall be required to submit verification of catastrophic illness in the form of a written medical statement from the attending physician indicating the nature of the illness/injury and the probable length of absence from work.
- 11.15cc The Catastrophic Leave Committee may require a medical review by a physician of the Committee's choice. The Committee shall choose only a physician who participates in the Bargaining Unit Member's medical plan. The District shall reimburse any co-pay and mileage incurred by the Bargaining Unit Member for the review.
- 11.15dd Refusal to submit to the medical review will terminate the Bargaining Unit Member's continued withdrawal from the CLB.
- 11.15ee The Bargaining Unit Member shall waive any and all claims against the Board of Education, District, and its officers and employees, arising from the administration of Catastrophic Leave.
- 11.15ff Members of the Catastrophic Leave Committee shall not divulge personal information about any participant including but not limited to the nature of the illness.
- 11.15gg Any fraudulent use of the CLB shall result in a demand for reimbursement of the cost of the days granted, garnishment of wages if not repaid within 30 days of demand for reimbursement, and will terminate the Bargaining Unit Member's participation in the CLB program.
- 11.15hh In the event that the parties negotiate the termination of Catastrophic Leave, the days remaining in the CLB shall be returned to the then

current members of the CLB in the amount calculated by dividing the number of remaining days. Partial days may be applied to retirement but not sick leave days.

**11.16 Reinstatement Rights**

The employee has the right to return to the same site if the length of the leave is for an entire semester or less.

**ARTICLE 12 - WAGES**

**12.1 Definition of Experience**

**12.1a** Upon employment, teaching experience consisting of one full semester in a school year will count as one year of experience, but limited to one year. Full prior experience shall be granted, including accredited private and parochial school experience under a valid credential.

**12.1b** Effective 2022-2023, verified nursing experience will be considered for years of experience while holding a Bachelor's degree and RN license. Nursing experience consisting of one full semester in a school year or one-half of a calendar year of clinical experience will count as a full year, but limited to one year. All years of prior experience may be granted, including accredited private, parochial school, and/or experience working in a clinic or hospital setting.

**12.2a** All units earned subsequent to the B.A./B.S. degree, except District in-service credits and other special or conditional situations approved in advance by the Superintendent or his/her designee, must be upper division or graduate level units from an accredited institution with a grade of at least "C" and be applicable to a credential, degree or assigned responsibilities of the employee.

**12.2b** No more than nine (9) in-service credits may be applied toward the fifteen (15) units required for advancement from one group to another group on the salary schedule. All continuing education units approved by the Board of Registered Nurses may be applied by nurses toward the fifteen (15) units required for advancement from one group to another group on the salary schedule. All employees taking District approved course work for District Certification under

the District master plan for LEP Student Services shall receive salary advancement at the rate of one credit per 15 hours. For the purpose of this section, fifteen (15) clock hours equals one (1) credit hour.

Employees assigned to Primary Language Instruction Classes/ Language Acquisition Program Classes, English Plus Classes, and 7-12 ELD classes who complete within a year, two semesters of District approved language course work for District Certification under the District Master Plan for LEP Student Services will be reimbursed at the current hourly rate up to a maximum of 30 hours per year.

In addition, those employees assigned to Primary Language Instruction Classes, English Plus Classes, and 7-12 ELD classes who have been District Certified under the District Master Plan for LEP Student Services, who wish to continue additional language course work and complete a minimum of one semester of District approved course work will be reimbursed at the current hourly rate up to a maximum of 30 hours per year.

- 12.2c Graduate units earned prior to receipt of a B.A. degree will be accepted for salary placement only if graduate credit was granted upon course completion and noted on the official transcript.
- 12.2d Theological degrees and/or units will be counted only if applicable to the assigned responsibilities of the employee, or if required for a credential as defined by the Commission on Teacher Credentialing.
- 12.2e To receive credit for advancement on the salary schedule, all course work including District In-Service Education credits must be completed by the first workday. Official transcripts and/or records of In-Service Education credit must be submitted to the Office of Personnel Services prior to November 1. Certificated employees will not be advanced on the salary schedule as a result of courses taken during a current school year.
- 12.2f It shall be the responsibility of the employee to obtain prior approval from the immediate supervisor and the Office of Personnel Services for courses, other than those offered through the District In-Service Education Program, in which they plan to enroll prior to presentation for credit toward advancement on the salary schedule. The immediate supervisor shall give guidance and direction to employees to assure that courses taken are applicable to the assigned responsibilities of the employee, unless required for a credential or degree. Final approval must be granted by the Office of Personnel Services.
- 12.2g The salary schedule "steps" shall be defined as the vertical movement of employees on the schedule. Each year of experience in the Garden Grove Unified School District, including those years acceptable from another district, shall be the criterion for vertical progression on the schedule.

- 12.2h To receive credit for vertical advancement on the salary schedule an employee must teach 75 percent of a school year. Days served on jury duty will not be deducted when calculating days for salary advancement.
  - 12.2i The salary schedule "groups" shall be defined as the horizontal movement of certificated employees on the schedule. Completion and verification of the required academic credits and/or In-Service Education units shall be the criteria for horizontal advancement on the salary schedule. An employee may advance a maximum of two groups in any school year.
  - 12.2j All units are semester units. Quarter units shall be defined as two-thirds (2/3) of a semester unit.
  - 12.2k Step 16 in Groups IV and V, and Steps 20 and 25 in Group V are designated as anniversary increments. Anniversary steps are for continuing competent service and professional growth.
  - 12.2l Educational Specialists shall receive an annual honorarium of \$650.00 beginning in the 2019-2020 school year.
  - 12.2m Teachers who possess a Bilingual Authorization and are actively teaching in a Dual Immersion program shall receive an annual honorarium of \$650.
  - 12.2n Teachers who act as administrative designee shall receive hourly pay for covering IEP's outside of the contractual day.
  - 12.2o Preschool teachers with a valid California Multiple Subject teaching credential will receive a \$1,500 annual stipend.

4. The compensation rates in 12.3g (1) and 12.3g (2) will be applied to District approved site level professional development outside of twelve (12) hours stated in Section 4.3.
5. Members shall be paid hourly for attending district approved conferences and professional development that is mandatory for a program but outside the school day (even if it is not district sponsored).

- 12.3m K-12 teachers who attend overnight trips for the purpose of student supervision, shall receive recognition compensation in the amount of \$75.00 per night, not to exceed \$375.00. This includes, but is not limited to, teachers who supervise Outdoor Science School, AVID college trips, Washington D.C. trips, and ASB Camp. Teachers who receive a stipend that includes overnight trips will not be eligible for the additional recognition compensation, with the exception of ASB directors who supervise ASB camp.**

**12.4 Adult Education**

- 12.4a Teachers of classes for adults shall be granted seniority rights from the first date of service in the District.**

- 12.4b Effective with the 2000-2001 school year, persons teaching twenty-five (25) hours or more a week are to be considered full-time employees and will receive all full-time employee benefits.**

- 12.4c Full-time Adult Education Teachers will receive pay if their assignment falls on any District-approved legal holiday, except the Winter and Spring recesses, unless authorized to work during those recesses.**

- 12.4d Each full-time Adult Education Teacher shall receive a list of all**

District-approved legal holidays, for which he/she shall be paid during the term of a contract, immediately upon signing the contract.

- 12.4e Effective the 2012-2013 school year, Adult Education Teachers shall be compensated on the salary schedule as reflected in Schedule B.

#### 12.5 State Pre-School Teacher

- a. Effective the 2012-2013 school year, Pre-School Teachers shall be compensated on an annual preschool salary schedule as reflected in Schedule B.
- b. Effective the 2020-2021 school year, each state Preschool employee shall have the opportunity to attend and be compensated for professional development activities beyond the school day/year at the hourly rate of 1/1000 of the current Step 1 Group 2. Professional development activities attended during the week prior to the school year shall be paid at the hourly rate of the subsequent school year.

#### 12.6 Mileage

Employees whose responsibilities require travel to more than one site shall receive, if requested, mileage reimbursement at the current IRS rate.

#### 12.7 Part-Time Employment Plan

In accordance with Education Code Sections 44922 and 22724, a certificated employee of the Garden Grove Unified School District may reduce his/her work load prior to retirement from full-time to part-time duties and receive the same credit toward retirement he/she would receive if he/she were employed on a full-time basis. Regulations governing this provision are as follows:

- 12.7a The employee must have attained the age of 55 years prior to the time the work reduction begins.
- 12.7b The employee must have been employed as a full-time certificated employee for at least ten (10) years, of which the last five (5) years were in full-time employment in the Garden Grove Unified School District.
- 12.7c Entry into the five-year Part-Time Employment Plan must be exercised at the request of the employee and termination of the plan thereof can be only with mutual consent of both employee and employer. (Final approval of employee participation would rest with the District.) It is understood that at the termination of the five-year period, the employee will begin his/her retirement. However, in the event of proven hardship, the District may grant an exception (e.g., death, divorce, bankruptcy, etc.).
- 12.7d Option to participate in the Part-Time Employment Plan shall be through written request of the employee to the Assistant Superintendent, Personnel Services. Deadline for submitting a request to participate in the Part-Time Employment Plan shall be March 15 of any given school year. Such request as noted above is to be submitted on the District Form No. 9701.94, "Request to

**Participate in Part-Time Employment Plan."**

- 12.7e** The employee shall be paid a salary which is the pro rata share of the salary he/she would be earning had he/she not elected to exercise the option of a part-time employment, but shall retain all other rights and benefits for which he/she makes the payments that would be required if he/she remained in full-time employment. The employee shall receive all fringe benefits as provided in Section 53201 of the Government Code in the same manner as a full-time employee.
- 12.7f** Minimum and maximum part-time employment shall be as follows:
- Teachers at TK-6 level will be required to teach 100 percent of one semester and 0 percent of the other semester.
- Teachers at 7-12 level may teach either 100 percent of one semester and 0 percent of another, or one-half day basis for the entire year. One-half day is defined as three teaching periods as mutually agreed, exclusive of lunch.
- Non-classroom employees who are members of the Association will be required to be on duty either (a) 100 percent of one semester and 0 percent of the other semester; or (b) one-half day basis for the entire year, hours as mutually agreed upon.
- 12.7g** A certificated employee may not participate in this plan for more than five (5) years.
- 12.7h** Deductions for State Teachers' Retirement System contributions by the District and by the part-time employee shall be equal to the amount required of a full-time employee. Deductions are to be made on a monthly basis depending on the pay program selected by the employee.
- 12.7i** Each certificated employee participating in this plan will earn sick leave in proportion to the percent of employment per year. Example: 50 percent (half-time) employment would yield sick leave of 50 percent of ten days or five days of sick leave. Such sick leave would be accumulative.
- 12.7j** The Optional Part-Time Employment shall be limited to 45 members of the Association per school year.
- 12.7k** The District agrees to announce annually the availability of the Part-Time Employment Plan to all employees.
- 12.7l** All provisions of this program will be available to each employee through building principals and administrative department heads.
- 12.7m** Participating employees will be scheduled for individual meetings by the Office of Personnel Services to develop a mutually agreeable program for the employee on or before May 1.
- 12.7n** Where two or more employees apply for the same part-time position such position shall be filled by the employee with the greatest

District-wide seniority.

- 12.7o Employees who participate in the Part-Time Employment Plan will perform extra duties proportionate to full-time employees. (Half-time employees will perform half as many duties as full-time employees.)
- 12.7p After June 1, the District shall provide the Association with a list of teachers who have been approved for part-time employment for the following year.
- 12.7q The agreement between the Board and the participating teacher will be finalized on or before May 15. (The teacher may be accompanied by a representative of the Association in any meeting he/she attends with the District, pursuant to this Article.)
- 12.7r Application for participation in the program shall be completely voluntary and at the discretion of the employee.

## 12.8 Salary

The District agrees to increase the 2022-2023 salary schedules 3.5% for the 2023-2024 school year, including Preschool and Adult Education teachers teaching twenty-five (25) hours or more. (Retroactive to July 1, 2023).

## 12.9 Job Sharing

- 12.9a The District shall offer permanent employees the opportunity to voluntarily share the responsibilities, wages, and benefits of a teaching assignment.

The two (2) employees sharing a contract may choose to work half of every day, all day on five (5) out of every ten (10) workdays, or one (1) of two (2) semesters in the school year.

The deadline for submitting a request to participate in Job Sharing shall be March 15 of any given year.

- 12.9b Participating employees and the District shall mutually agree on and sign a written copy of the terms and conditions of their job sharing. Job sharing plans shall conform to all other provisions of this Agreement.
- 12.9c Job shares shall not be dissolved if the dissolution would result in any currently employed teacher losing a teaching position.

## 12.10 Employee Personal Property

The District shall replace or reimburse employees for the cost of replacing or repairing personal property damaged or lost in the performance of their duties subject to all of the following conditions:

1. The property is the type that is necessarily worn by the employee.
2. The property was lost or damaged through no fault of the employee.
3. The value of the property, which shall be determined as of the time of the loss or damage, is greater than \$50 and less than \$750.

4. The employee will use all other available methods to recover compensation before making a claim against the District.

### **ARTICLE 13 - HEALTH AND WELFARE BENEFITS**

The District and the Association are committed to maintaining a quality health and welfare benefits program for all employees. The parties agree to a good faith effort and commitment to maintain a program which is comprehensive and cost-effective.

#### **13.1 Medical Plans**

- 13.1a The District shall provide full-time employees and eligible dependents, including spouses and domestic partners with a medical services insurance plan. The employee shall have a choice from among no less than three (3) plans (Fee for Service, Exclusive Provider Organization, Health Maintenance Organization) provided by the District.

Plans will provide benefits as outlined in the following schedule to be administered as set forth in the Summary Plan Descriptions.

**C. Effective with the 2019 Plan Year, the District will provide Live Health On-Line**

- a. The Live Health Co-Pay shall be \$15

**13.1b** The District shall provide a medical services insurance plan for retiring employees to age 65 and for disabled employees, age 50 or older. The retiring or disabled employee shall have a choice from the

plans provided by the District. The retiring employee must have served at least ten (10) years and have retired from the District as defined in Education Code Section 22148. The disabled employee must have served fifteen (15) years in the District. A District-approved leave shall constitute a year of service for the purpose of eligibility for this benefit.

- 13.1c The District shall provide medical insurance for the spouse or domestic partner of an employee who qualifies for the provisions in 13.1b.
- 13.1d Pre-authorization is required in the fee-for-service medical plan for outpatient services as indicated in the Summary Plan Description.
- 13.1e Mail Order Prescriptions:  
One co pay is required for each month's prescription drugs.
- 13.1f The District will provide employees access to an 800 number for medical questions.
- 13.1g The medical and dental fee-for-service plans will include a third party recovery clause for all employees and a pre-existing condition clause in the medical plan for new hires.

## 13.2 Dental Plans

The District shall provide full-time employees and eligible dependents, including spouses and domestic partners with a dental services insurance plan. The employee shall have a choice from between two (2) plans (Fee for Service and Pre-Paid) provided by the District.

The plans will provide benefits as outlined in the following schedule to be administered as set forth in the Summary Plan Descriptions.

  - 2. Orthodontia
    - a. Plan Maximum

- B. Pre-Paid Dental
  - 1. Dental
    - a. Preventative Procedures Co-Pay -0-
    - b. Restorative Dentistry Co-Pay -0-
    - c. Crowns/Bridges Co-Pay (gold excluded) -0-
  - 2. Orthodontia (banding only)
    - a. Co-Payment \$1500 up to age 23
    - b. Co-Payment \$2000 age 23 and above

13.3 Vision Plan

The District shall provide full-time employees and eligible dependents, including spouses and domestic partners with a vision insurance plan. The plan shall be special "Plan B" of California Vision Services, or its equivalent, except that tinted or photo-chromatic lenses shall be covered by the plan. The plan will provide as outlined in the following schedule, to be administered as set forth in the Summary Plan Description.

13.4 Life Insurance

The district shall provide all eligible employees with a \$50,000 term life insurance policy, to include a provision for dependent life coverage and an age reduction schedule complying with Age Discrimination Act regulations.

13.5 Limitation of Benefits

13.5a All health and welfare benefits shall be maintained and premium increases shall be paid by the District for the duration of this contract.

13.5b Effective with the September 2010 payroll, in order to receive the medical, dental, and vision benefits package described in Sections 13.1a, 13.2, and 13.3, all eligible employees enrolled in the group health program shall make a tenthly payroll deduction contribution based upon the following schedule:

- Employee - \$50
- Employee plus children - \$75
- Employee plus spouse or domestic partner - \$100
- Employee plus family - \$150

13.5c Effective January 1, 2025, an employee who is eligible to receive the medical benefits described in Sections 13.1b and 13.1c shall have the option to also receive dental and vision coverage and make a yearly contribution based on the following schedule:

13.6 Duration of Benefits

13.6a The benefits provided in this Article shall remain in effect during the term of this Agreement.

13.6b The Association shall be consulted before any change in carriers or administrators of the health and welfare benefits plan is made.

13.6c Full-time employees who are absent on account of illness and who have exhausted their accumulated sick leave shall continue to receive full health and welfare benefits paid by the District for six (6) months from the first day of the month following the last day worked, or until exhaustion of all paid leaves, whichever is longer.

13.6d Employees on District-approved leaves of absence without pay shall be given the option of converting to a health and welfare benefit plan for the period of the leave, at the employee's expense.

13.6e An employee who has been actively employed on a regular full-time basis through the end of the contractual school year, will have continuous coverage through the day before the start of the teacher contract the following year. Should an employee give notice to terminate, coverage would end on the first day of the month following such notice.

13.7 Miscellaneous

13.7a Each employee in the bargaining unit shall receive from the District

a full explanation of all health and welfare benefits - including carriers, coverage, and other pertinent information.

13.7b Examinations for tuberculosis will be required every four years. The examination may be either an x-ray, a skin test, or questionnaire. The District shall arrange and pay for these tests.

13.7c Employees will be provided the opportunity annually to change health plans during a 30-day open enrollment period.

13.7d Employees will be provided the opportunity to terminate coverage for themselves, or any eligible family member, the first of the month following the submission of a written request to cancel coverage. The enrollment of eligible employees and family members will be in accordance with the Summary Plan Description and shall include the following:

- 1) First of the month following the elected change during the thirty (30) day annual open enrollment period.
- 2) For new spouse or domestic partner, the first of the month following date of marriage or domestic partnership.
- 3) Newborns coverage from date of birth.
- 4) An employee, spouse, or domestic partner, or child with coverage outside of the District whose coverage was terminated as a result of the spouse's/domestic partner's termination of employment could be enrolled the first of the month following the date of termination of benefits.

Change requests for items 2, 3, and 4 are to be submitted in writing within thirty (30) days of the date of marriage, domestic partnership, birth, or termination of benefits.

13.7e The District and the Association agree to participate in an ongoing study, analysis, and education program in health benefits. At least four insurance newsletters shall be prepared and distributed to all employees each school year.

13.8 The District shall provide for employee participation in the Medicare program to begin within the last quarter of the 1991 calendar year.

#### **ARTICLE 14 - ASSOCIATION RIGHTS**

14.1 The Association and the District agree that the District will provide the Association with access to employee orientation sessions and shall jointly enact all aspects of AB 119, including new employee orientation covering aspects of the onboarding process such as: employment benefits, rights, duties and responsibilities.

In order to achieve access to employee orientation sessions, the Association and the District agree to the following:

14.1a The District shall provide the Association with a new employee's name, job title, home and personal cell phone numbers, personal email addresses on file, and home address, as hired. The work

location and work phone number shall be reported to the Association, when available.

- 14.1b The annual orientation meeting shall be held at a mutually determined location, date, and time prior to the start of the school year. The Association shall be provided no less than 60 minutes of uninterrupted time to communicate with the bargaining unit members at all orientations/onboarding meetings without district personnel present. The Association is entitled to invite vendors and CTA staff to the Association portion of new bargaining unit member orientations/onboarding meetings.
  - 14.1c For new employees hired after the annual orientation meeting, the District will notify the Association of new hires one time per month at the start of the next pay period. Subsequent monthly orientations for new hires shall be held monthly at the GGEA office. The dates and times of these monthly meetings shall be mutually determined by the Association and the District.
  - 14.1d In addition, the District shall provide the Association with each bargaining unit member's name, home address, phone numbers – work, home, cellular, personal email address, work site, date of hire, full time equivalent (FTE) status, and employment status (i.e., Probationary, Permanent, Temporary, etc.). This member information will be provided to the Association in Excel spreadsheet format three times per year: the first duty day in September and February.
- 14.2 The Association shall have the right of access at reasonable times to areas in which employees work; the right to use institutional bulletin boards, mailboxes, and other means of communication, subject to the following regulations:
- 14.2a. Materials to be posted on designated faculty lounge bulletin boards shall be dated.
  - 14.2b. Materials sent through District mail shall originate in the Association Office only and shall be so identified.
  - 14.2c. Information distributed through the District mail or posted on designated bulletin boards shall be reasonable.
  - 14.2d. Copies of District-mailed material will be routed to District Office of Informational Services before mailing.
- 14.3 The use of released time allocated to the Association by the District must be authorized by the Association. At least seventy-two (72) hours in advance of the release date, the Association shall contact the Office of Personnel Services in order to agree on the employee(s) and date(s) of release.
- 14.4 The Association shall be provided with any public information required, including, but not limited to, class size, statistical reports, and budgetary information.

- 14.5 Association meetings called at school sites are open only to members of the Association and/or bargaining unit, and guests invited by the Association.
- 14.6 The Association shall receive as a maximum each year, fifty (50) released days, plus one-eighth (1/8) day per member of the bargaining unit, as of November 1, 1980, for the purposes of meeting and negotiating, and for the processing of grievances during the term of this contract.
- 14.7 The provisions of the Agreement shall not be interpreted or applied in a manner which is capricious or discriminatory. Rules which are designed to implement this Agreement shall be uniform in application and effect.
- 14.8 Payroll Deductions
- 14.8a The District shall deduct authorized Association dues/fees in accordance with written notice from the Association. The District will guarantee to maintain authorized payroll deduction of dues/fees by members required under the terms set forth above and provisions of the Education Code and Government Code section 3540.1(i)(1) of Division 4 of Title 1. Such authorized deductions shall continue when a member returns from unpaid leave.
  - 14.8b The District shall deduct authorized contributions to the Fund for Children and Public Education.
  - 14.8c The District shall deduct authorized contributions to the Foundation to Assist California Teachers.
  - 14.8d The District shall give employees an opportunity to have their paychecks directly deposited in any bank, credit union, or savings and loan participating in the direct deposit program.
  - 14.8e Employees may participate in any tax sheltered annuity/deferred compensation life insurance plan and/or shares in a regulated investment company of their choice with the District providing payroll deduction for this purpose.
  - 14.8f Employees may participate in a 125 Flexible Benefit Program for the employee contribution to the Health Services Insurance Plan, medical reimbursement including eligible over-the-counter purchases (to a maximum of \$2500 per year), and dependent care expenses with the District providing payroll deduction for this purpose.
  - 14.8g Employees may participate in the Voluntary Receivable Program with the State Teachers' Retirement System, which is a tax deferred payroll deduction payment process for redeposit of previously withdrawn contributions and/or purchases of permissive service credit, with the District providing payroll deduction for this purpose.

- 14.9        **Negotiation Procedures**
  - 14.9a      Not later than April 1 of the calendar year in which this Agreement expires, the Board shall meet and negotiate in good faith with the Association on negotiable items. Any agreement reached between the parties shall be reduced to writing and shall be signed by both.
  - 14.9b      Either party may utilize the services of outside consultants.
  - 14.9c      The Board and Association may discharge their respective duties by means of authorized officers, individual representatives, or committees.
  - 14.9d      Negotiations shall take place during the regular school day and at other mutually agreeable times. The locations shall be mutually agreed upon. Such meetings shall be held within a reasonable time upon request.
- 14.10      A booklet of current Side Letters of Agreement will be printed for the membership of GGEA as needed.

**ARTICLE 15 – JUNIOR RESERVE OFFICER TRAINING CORPS INSTRUCTORS (JROTC)**

- 15.1        **Holidays**            Refer to Article 4.7 for Calendar Guidelines.
- 15.2        **Sick Leave**
  - 15.2a      JROTC Instructors who are regularly employed are entitled to one (1) day paid sick leave for each month worked. Unused sick leave may shall be accumulated without limitation.
  - 15.2b      Three (3) days of Family Illness Leave shall be allowed to JROTC according to the procedures in Article 11.4a – Family Illness Leave. These days do not accumulate.
- 15.3        **Grievance**
  - 15.3a      The District and the Association will follow the procedures outlined in Article 5, Grievance Procedures of the Association Collective Bargaining Agreement, for the resolution of such problems as may arise involving the interpretation, application, or violation of this Article.
  - 15.3b      JROTC Instructors shall be afforded the due process rights of all bargaining unit members in accordance with California Ed Code.
- 15.4        **Evaluation Procedures**
  - 15.4a      The District and Association shall follow the procedures outlined in

Article 7 – Evaluation Procedures, in the Association Collective Bargaining Agreement, except for 7.3 Frequency and 7.4b and c. Frequency and observation types for JROTC Instructors are outlined in the chart below:

**15.4b Frequency**

Starting in the 2023-2024 school year, JROTC shall be evaluated on the following schedule:

**15.4c** For JROTC educators who require a SDAIE waiver, a modified evaluation in the educator’s off year shall take place. The evaluation shall be based on the educator’s choice of one scheduled or one unscheduled observation.

**15.5 Health Care**

JROTC Instructors shall be eligible to participate in the health and welfare benefits outlined in Article 13, Health and Welfare Benefits of the Association Collective Bargaining Agreement.

**15.6 Wages**

**15.6a** Starting 2023-2024 school year JROTC instructors shall receive a Stipend of \$8000 annually, to be paid in two equal portions on December 31 and April 30.

**15.6b** JROTC shall receive overnight pay as outlined in 12.3m.

**15.6 c** JROTC Instructors shall receive a compensation day for every Holiday worked.

## **ARTICLE 16 - SAVINGS**

- 16 If any provision of this Agreement or any application thereof to any employee is held by a court of competent jurisdiction to be contrary to law, then such provision or application will be deemed invalid, to the extent required by such court decision, but all other provisions or applications shall continue in full force and effect.

## **ARTICLE 17 - COMPLETION**

- 17.1 This Agreement constitutes the entire Agreement between the parties and concludes meet and negotiate on any item, for the term of this Agreement except that:
- 17.1a The Association and the District may amend the contract by mutual written agreement only.
  - 17.1b Should the Board authorize the reorganization of a school with a 5-6-7 or 6-7-8 configuration, the District and the Association shall meet within ten (10) workdays to negotiate contractual ramifications.
  - 17.1c Negotiations on the following Articles shall be reopened upon the written request of either party: (1) Article 4: Hours of Employment, (2) Article 9: Class Size, (3) Article 12: Wages, (4) Article 13: Health and Welfare Benefits, and one other Article as the parties mutually agree. (For the 2018-2019 school year paragraph 17.1c shall not be applicable.)
- 17.2 During the period of this contract, should PERB rule that certain items are included within the scope of negotiations, or should the State of California adopt a law that changes any item within the scope of negotiations, as defined in Section 3543.2 of the Government Code, or should the Federal Government adopt a law that affects any provision of this agreement, the District and the Association shall reopen negotiations, at the request of either party, on those items only.
- 17.3 Each party shall appoint one or two representatives for the purpose of contract maintenance. The representatives shall meet weekly unless they mutually agree to cancel a meeting.

## **ARTICLE 18 - PROFESSIONAL GROWTH**

The District shall implement a professional growth program consistent with the requirements and recommendations of the California Professional Growth Manual dated September, 1985, except that:

- 18.1 The District shall designate certificated administrators to serve as Professional Growth Advisors.
- 18.2 An employee whose Professional Growth Plan is not certified, initialed, and/or verified as requested may appeal the determination to the Executive Secretary of the California Commission on Teacher Credentialing.

18.3 Upon the request of the employee or a Professional Growth Advisor, the president of the Association shall provide verification of participation in or completion of Association-related activities.

Special Education Class Size and Release Time for M/M and M/S Teachers

Garden Grove Education Association, GGEA, and Garden Grove Unified School District, the District, recognize that having more students in a Mild to Moderate (M/M) or Moderate to Severe (M/S) class requires additional preparation time; therefore, the District and the Association agree to the following:

TK-6 M/M teachers shall have an informal class cap of 18:1 (M/M students only, not inclusive of RS or Gen Ed). Should a TK-6 M/M student be added in excess of the informal class cap at any time, the teacher shall receive a \$400 stipend per each additional M/M student over 18. This will be allocated one month following the addition of each student.

TK-12 M/S teachers shall have an informal class cap of 12:1. Should a TK-12 M/S student be added in excess of the informal class cap at any time, the teacher shall receive a \$400 stipend per each additional M/S student over 12. This will be allocated one month following the addition of each student.

The District further agrees that music education has high value for all of our students. Therefore, the District will provide 30 minutes weekly music time for our students in 7-12 M/S classes, which will provide 30 consecutive minutes of weekly preparation time for the 7-12 M/S teacher. When music instruction cannot be provided, the M/S teacher shall have 30 consecutive minutes of weekly preparation time.

- Provide a full day Instructional Aide II coverage for every TK/SpEd co-teach classroom for the 2024-2025 school year.
- Provide .5 of a full day Intensive Behavioral Instruction (IBI) Aide for every TK/SpEd co-teach classroom for the 2024-2025 school year.

In the event that a Transitional (GE or SpEd) teacher is placed on assignment for up to two years, the teacher shall have the right to return to their previous work site upon the conclusion of their assignment. This is retroactive for the 2023-2024 MOU.

This MOU shall remain in effect August 10, 2024 through May 30, 2025.

**Pay for Extended Learning Opportunities**


In order to provide additional academic and/or personal skills support, the Association and District agree to the following:

Unit members who provide District Goal 1 (Academic Skills) and/or Goal 2 (Personal Skills) support to students as a part of a school-sponsored and district-approved Extended Learning Opportunities program outside the contractual day will receive an hourly wage of 1.4/1000 of Group 1, Step 1.\*


Unit members are contractually required to be present for 30 minutes prior to the start of the instructional day unless some of this time was banked for the creation of collaboration time. Upon approval by the site Principal and appropriate Assistant Superintendent of Elementary/Secondary Education, a school may allow a teacher to provide before school targeted interventions to students that end no less than 15 minutes before the start of school. A teacher may be compensated for before-school direct support for students **only** if preapproved and if s/he arrives at school prior to the onset of the intervention for the contractual before school minutes currently established at each school.

This MOU shall remain in effect August 14, 2023 through May 31, 2024 and will be the last year (non-renewable) due to the end of funding.



**Differential Pay**

Garden Grove Education Association, GGEA, and Garden Grove Unified School District, the District, recognize that increasing the substitute teacher rate for the 2021-2022 school year may cause additional hardship on members who are receiving differential pay. In an effort to alleviate this hardship GGEA and the District have agreed to the following:

For the 23-24 school year, employees in the bargaining unit whose illness/injury benefits have been consumed and must still be absent from duty because of illness or injury shall receive that amount of pay which is the difference between their pay and a \$150 daily amount or \$175 long term amount paid for a substitute employee, whether or not a substitute is employed. This rate is to be used for the remainder of this school year only, for no more than 100 days, commencing with the exhaustion of their accumulated sick leave.


**Compensation for Teachers Covering During Substitute Shortage**

Garden Grove Education Association, GGEA, and Garden Grove Unified School District, the District, recognize that there is a county, state and nationwide substitute shortage, resulting in an inability to cover all GGUSD contractual release days as scheduled. In an effort to alleviate this shortage and ensure substitute coverage for teachers' illness, PN and FI, GGEA and the District have agreed to the following:

- 9-12 teachers and 7-8 Special Education teachers, who have a preparation period, will receive one hour at the current hourly rate of 1/1000 of Group 1, Step 1\* when covering another class during their preparation period, but only when a substitute is not available, and the teacher is asked to cover the class by site administration. In addition, 9-12 teachers shall receive a proportional amount of an hour of the current hourly rate of 1/1000 of Group 1, Step 1\* when additional students are assigned to their classroom at a time other than their prep period. At no time will a class be split to more than 3 teachers.
- TK-6 teachers, including Education Specialists covering for another Ed Specialist, will receive a proportional amount of \$300 per day, when additional students are assigned to multiple classrooms, but only when a substitute is not available. A class shall be split as evenly as possible among receiving teachers. At no time will a class be split to more than four teachers.





- Eligible teachers in grades Preschool-8 will have the option to take all of their Contractual Release Days or trade all of them for a payment of \$300 per day.
- Eligible Preschool-6 Education Specialists and Mark Twain SDC Teachers will have the option to take all of their IEP Prep Days or trade all of them for a payment of \$300 per day.
- High School Education Specialists will have the option to take all of their IEP Release Days or trade all of them for a payment of \$300 per day.
- Eligible teachers will have 10 work days from the date of the announcement to make their selection, or the release days will default to compensation.
- Education Specialists will have 10 work days from the date of the announcement to make their selection, or the release days will default to compensation.

**All teachers selected for online classes must:**


- Be properly credentialed or authorized in the content area offered

  - using basic technology such as, word processing, spreadsheet, Internet search engines, presentation software
  - using the basic elements of an online course such as, email, posting and downloading files and navigating a Web site


**Responsibilities** of online teachers include:

- § Meeting a minimum of three times per semester with online students (orientation, benchmark testing)
- § Working with administrative/counseling team to recruit, select, place and monitor students
- § Working with district office liaison, Mark Marlola, and/or TOSA, to ensure effective implementation
  - attend all meetings and trainings associated with management of class
- § Devoting the hours necessary to effectively teach an online course, including posting lessons, assignments, grades, etc; answering student e-mails; assessing student work; monitoring student progress
- § Intervening as necessary to assist struggling students
- § In concert with site admin team, follow student drop guidelines
- § Conducting a course evaluation to determine course strengths and challenges
- § Maintaining office hours to meet with students needing additional assistance

*Consult Procedure*

The District and the Association agree to memorialize their long-standing agreement regarding Consult procedures as follows:


Pursuant to Section 3543.2 of the Educational Employment Relations Act (EERA), certificated employees may "consult" with the District over educational objectives, the content of courses and curricula, and the selection of textbooks. Furthermore, any subject that clearly relates to these enumerated items may also be the subject of a consult. Either party may call for a consult or both parties may agree that a consult is needed.


Dates and Locations: It shall be the responsibility of K-6 and/or 7-12 Instruction to arrange dates and locations for consults. The name, dates and locations of each consult shall be communicated to the Association via phone, fax or e-mail.

Participants: The Directors of K-6 and/or 7-12 Instruction shall identify potential participants who have expertise in the specific area and forward the list to the Association. The Association may request assistance from the Teachers on Special Assignment, so that the best qualified representatives may be located for each consult. The Association and the District shall collaboratively select members to serve on each consult.

Notification of Participants: The Association shall contact its member participants and provide them with information about the consult, including dates, locations and general purpose. The District shall notify its member participants and provide them with information about the consult, including dates, locations and general purpose.

Consult Report: The Consult shall reduce its findings or recommendations to writing and provide the participants and the Association with copies thereof. A minority report may be filed by any group of participants who believe that the majority consensus is in error.

**REVISED SIDE LETTER ON JOB SHARING**

In the interests of avoiding Reductions in Force (layoffs) and placing limitations on the number of job shares or the number of years teachers can job share, the District and the Association have agreed that commencing 2008-09 dissolving existing job shares will not be allowed if the dissolution would result in any currently employed teacher losing a teaching position.

Further, the parties hereby agree to the following procedures:


1. The District shall give written notification to all job share teachers of the need to invoke this Agreement as soon as they become aware of the possibility of any currently employed teacher losing a teaching position. Further, the notice shall direct the teachers to send their written requests to dissolve their job shares to the District Personnel Office. The District Personnel Office shall date and time stamp the written requests upon receipt. Once the requests have been dated and time stamped by the District Personnel Office, they shall remain effective until withdrawn by the submitting teacher.


2. Teachers exiting job shares will be interviewed and placed according to their position on the time and date stamp lists. Any remaining teachers shall be retained on a waiting list.

3. If the request for the dissolution of a job share is submitted to the Personnel Office before the school year starts, then the least senior teacher on the staff will be excessed from the school site in conformance with Contract Section #10.11.

4. If the request for the dissolution of a job share is submitted to the Personnel Office during the school year, the teacher requesting the dissolution shall be excessed from the school site.

5. If both partners request the dissolution during the school year, then the least senior teacher shall be excessed from the school site. If the partners have the same number of years of experience in the District, then the principal shall determine which teacher shall be excessed from the school site.

1. This Side Letter of Agreement supersedes all past side letters of agreement regarding Special Education.
2. In order to improve communication between the Special Education Department and Special Education teachers, the District agrees to the following:
  - Any teacher who has questions related to Special Education, shall receive an answer within a timely manner. In most cases, this timeframe will be within under 48 hours
  - General information regarding district/department policy, curriculum and Professional Development will be disseminated directly to the Special Education and the General Education teachers on a regular and ongoing basis from the Department of Special Education and will be made available digitally.
  - Any updates or changes in Special Education case law or procedure shall be communicated to Special Education and General Education teachers.
3. Trainings on the SEIS Program, writing IEP goals and ProAct will be publicized directly to all Special Education teachers so that interested teachers may attend.
4. Professional Development opportunities to provide effective instruction to all students in Least Restrictive Environment settings will be available to all interested teachers. All Professional Development will be published in the monthly Professional Development calendars and in the Super Week catalogs.
5. Special Education class sizes will be monitored by the District and by the Association and adjusted to ensure that the numbers are balanced and appropriate for addressing the students' needs written in their IEP goals and objectives.
6. Designated Personnel will oversee the collaboration, writing and implementation of Behavior Intervention Plans. General Education and Special Education teachers will contribute to the development of behavior plans by providing input to the plan developer for students on their caseload or instruction periods, but will not be responsible for the writing of Individual Behavior Plans.
7. Special Education teachers shall be provided with appropriate district-based program materials and trainings, including Teachers Editions for all grades/subjects taught.

**ASSOCIATION DUES/FEES**

The District and the Association agree that the deduction of Association agency fees pursuant to the implementation of Senate Bill 1960 shall be as follows:

Commencing September 1, 2001, the Association implemented the collection of agency fees (fair share fees) pursuant to Senate Bill 1960, which became effective January 1, 2001. The District and the Association understand and agree that if S. B. 1960 is revoked, the Association will no longer have the legal right to collect agency fees (fair share fees) and any language in this Side Letter referring to the collection of said agency fees (fair share fees) will be revoked as well.

Any unit member, as defined in Article 2 of the Agreement between Garden Grove Unified School District and Garden Grove Education Association/CTA/NEA, who did not become a member of the Association on or before October 1, 2001, or does not become a member within thirty (30) days of the commencement of his or her assigned duties, shall pay to the Association a fee in an amount equal to the membership dues not including the EAC donation, payable to the Association in ten monthly installments by payroll deduction or in one lump sum within the first month of each school year of his or her employment. The District shall deduct said fees for all non-member unit members and transmit the fees to the Association in the same manner as the Association dues pursuant to Education Code Section 45061.

The only exception to the requirement of membership or the payment of agency fee is qualification as a religious objector. Any unit member who is a member of a religious body whose traditional tenets or teachings include objections to joining or financially supporting employee organizations or who holds sincere religious beliefs opposing unions or who has sincere religious objections to the policy positions of NEA and/or its state affiliates shall not be required to join or financially support the Association as a condition of employment, except that such bargaining unit member shall pay, in lieu of an agency fee (fair share), a sum equal to the full membership dues to one of the following non-religious, non-labor charitable funds exempt from taxation under Section 501c(3) of Title 26 of the Internal Revenue Code: The Boys and Girls Club of Garden Grove, The Assistance League of Garden Grove, and United Way.

In order to receive a religious exemption, the unit member must submit to the Association a detailed written statement establishing the basis for the religious exemption. The Association Board of Directors shall communicate in writing to the unit member its acceptance or rejection of the application for exemption. If accepted, the unit member shall make the payment to the charity as described above. Such payment shall be made on or before the due date for cash dues/fees for each school year. No in-kind services may be received for payments, nor may the payment be in a form other than money, such as the donation of used items. Proof of payment shall be made on an annual basis to the Association and District as a condition of continued exemption from the payment of agency fee. Proof of payment shall be in the form of receipts and/or canceled checks indicating the amount paid, date of payment, and to whom payment in lieu of the service fee has been made.

The District and the Association shall cooperate in maintaining an accurate listing of bargaining unit members, Association members, religious objectors and fee payers. The District shall provide the Association with written notice of all new hires, including their names, addresses, social security numbers and school assignments, as soon as practicable after their hiring.

With respect to all sums deducted by the District pursuant to sections above, whether for membership dues or agency fees, the District shall remit such moneys promptly to the Association accompanied by an alphabetical list of unit members for whom such deductions have been made, categorizing them as to membership or non-membership in the Association, and indicating any changes in personnel from the list previously furnished.

The Association shall indemnify and hold the District harmless against any reasonable legal fees, legal costs, and settlement or judgment liability arising from any court or administrative action relating to the school district's compliance with the Side Letter. The Association shall have the exclusive right to determine whether any such action or proceeding shall not be compromised, resisted, defended, tried, or appealed. This indemnification and hold harmless duty shall not apply to actions related to compliance with this section brought by the exclusive representative of district employees against the District.

**DEPARTMENT CHAIRPERSON ELECTION PROCEDURE**

**Nominations**

1. The nomination period shall be one week in length (five school days).
2. Nominations may be made by anyone teaching in the specific department. Each department member will be given a form for nominations along with a copy of the Department Chairperson job description. A department member may self-nominate or nominate other members of the department.
3. Nominations shall be made in writing and submitted to the school principal or his/her administrative designee.
4. A list of the department's nominees shall be shared with all department members following the completion of the nomination process.

**Election Process**

1. The names of all department members who have accepted the nomination shall be placed on a written ballot. Space shall be provided for write-ins.
2. Each department will have ballots printed on a different color paper.
3. Each department member shall be allowed the number of votes equal to the numbers of periods taught in that department. He or she shall receive one ballot per period taught in that department. Department members shall provide a signature indicating that they have received the proper ballots.
4. Department members shall be allowed one week in length (five school days) to cast their written ballots.
5. Ballots for all departments will be submitted to one secured ballot box which shall be kept centrally located and openly accessible in the main office.
6. At the end of the voting period, at a time and place previously announced, the ballot box shall be opened and the ballots shall be counted. The principal or his/her administrative designee must be present. Under no circumstances shall any candidate be allowed to tally ballots. Any member of the faculty shall have the right to be present while the counting takes place. Following the election, the submitted ballots shall be available for inspection for a period of one week.
7. The department chairperson will be selected by a simple majority vote.
8. In the event of a tie, the school principal shall have the authority to choose the chairperson.
9. Should a vacancy occur prior to the expiration of the term, the department will conduct an election within ten school days.

**For the 2001-2002 term the nomination and election process will start the first week of March and the department chair term will end the last school day of January. Stipends will be paid in three installments, May, November and January.**

Beginning January 2003, the nomination and election process will begin the last two weeks of January and the department chair term will start the first school day of February and end the last school day of January. Stipends will be paid in two installments, May and December.

**A Side Letter of Agreement  
between

Grade Level Chair Election Procedure**


**Nominations:**

1. The nominations period shall be one week in length (five school days).
2. Nominations may be made by anyone teaching in the specific grade level or grade level span.
3. The following grade level spans would be appropriate for representation for schools with insufficient candidates: TK/K-1, 2-3, 4-6. (A teacher may also be considered if he/she is teaching either one grade lower or one grade above his/her current assignment) if no one within the multi-level.
4. Nominations shall be made in writing and submitted to the school principal or his/her administrative designee.
5. A list of the grade level nominees shall be shared with all grade level members following the completion of the nomination process.

**Election Process**

1. The names of all grade level teachers who have accepted the nomination shall be placed on a written ballot. Space shall be provided for write-ins.
2. Each grade level will have ballots printed on different colored paper.
3. Each teacher shall have one vote per grade level taught. If the teacher is a combination teacher, that teacher will have one vote per grade level including the SDC teachers. The R.S. teacher(s) will have one vote per grade level with the highest number of students, with no more than two votes. Teachers in a job share will share one vote per grade level taught as above.
4. Grade level teachers shall be allowed one week in length, (five school days) to cast their written ballots.
5. Ballots for each grade level will be submitted in a secured ballot box which shall be kept centrally located and openly accessible in the main office.
6. At the end of the voting period, at a time and place previously announced, the ballot box shall be opened and the ballots shall be counted. The principal or his/her designee, and one teacher designated by the staff, must be present. Under no circumstances shall any candidate be allowed to tally ballots. Any member of the faculty shall have the right to be present while the counting takes place. Following the election, the submitted ballots shall be available for inspection for a period of one week.
7. The grade level chairperson will be selected by a simple majority vote.
8. In the event of a tie, the school principal shall have the authority to choose the chairperson if the tying teachers decline to share the position. (A grade level chair position may only be shared between two people.)
9. Should a vacancy occur prior to the expiration of the term, the grade level will conduct an election within ten school days.
10. 2015-16 October, 2015, the nomination and the election process will begin October 1 and be completed by October 9<sup>th</sup>.
11. 2016-2017 the nomination and election process will begin the 10<sup>th</sup> work day and be completed by the 15<sup>th</sup> work day.

A SIDE LETTER OF AGREEMENT

**PEER ASSISTANCE AND REVIEW PROGRAM**

1. **Purpose** – The Garden Grove Unified School District (*District*) and the Garden Grove Education Association (*Association*) agree to implement the California Peer Assistance and Review (*PAR*) Program as a critical feedback mechanism that allows exemplary teachers to assist teachers in need of development in subject matter knowledge, teaching strategies, classroom management, or in all three areas. This Program provides assistance to teachers in order to improve the teaching and learning process.
2. **Evaluation** – Change last sentence in Article 7, Section 7.6a to read as follows (*Italicized words – New Language*): “In accordance with Education Code, should the evaluation be unsatisfactory, ***the employee will be placed in the Peer Assistance and Review (PAR) Program*** and shall be evaluated each year until the evaluation is once again satisfactory.”
3. **Participating Teacher** – A Participating Teacher shall be a unit member with permanent status who is referred or volunteers to receive assistance and coaching to improve instructional skills, classroom management, knowledge of subject matter or in all three (3) areas.
  - A. **Referred Participating Teacher** – The Referred Participating Teacher shall be required to participate in PAR for a minimum of one (1) year as a result of an unsatisfactory final evaluation (Form “E”) in any of the above mentioned three (3) areas. A Referred Teacher shall participate in both assistance and review. The Referred Teacher shall be assigned a Consulting Teacher by the Joint Panel. The Consulting Teacher, Referred Teacher, and the Site Administrator shall meet to discuss the Peer Assistance and Review Program, and to establish mutually agreed upon performance goals with respect to the process of Peer Assistance and Review. The Consulting Teacher will provide assistance to the Referred Teacher until the Consulting Teacher concludes and reports to the Joint Panel that his/her performance goals have been achieved, or that further assistance will not be productive. Annually, the Consulting Teacher will submit a final report to the Joint Panel. The Consulting Teacher shall continue to provide assistance until the Joint Panel acts on the recommendation.

The Referred Teacher shall have the right to submit a request, in writing, to the Joint Panel for a different Consulting Teacher. He/she will state the reasons why the Consulting Teacher should be replaced and have those reasons considered. The Referred Teacher shall also have the right to submit a written response to the Consulting Teachers’ final report within ten (10) working days. The Referred Teacher may address the Joint Panel for up to five (5) minutes regarding the final report. A designee of the Association may accompany the Referred Teacher to this meeting.
  - B. **Volunteer Participating Teacher** – A Volunteer Participant may request the Joint Panel to assign a Consulting Teacher to provide peer assistance. The Consulting Teacher shall play no role in the evaluation of the teaching performance of the Volunteer Participant. The Volunteer Participant shall indicate area(s) in which he/she seeks assistance in his/her request (ex: New grade level, new subject area, etc). The Volunteer Participant may terminate his/her participation in the PAR program at any time

without the requirement to give a reason for said request. All communication between the Consulting Teacher and a Volunteer Participant shall be confidential; and without the written consent of the Volunteer Participant, shall not be shared with others, including the site principal, the evaluator, or the Joint Panel.

4. **Consulting Teacher** – A Consulting Teacher shall be a permanent certificated unit member, selected by the Joint Panel, who provides assistance to Participating Teachers.

A. **Application/Selection Process** – A notice of positions available will be posted at all work sites, the District Office, and the Association office. Applicants will submit the application form to the District along with three (3) references from individuals who have direct knowledge of the applicant's ability in both teaching and working with colleagues. At least one letter or recommendation will be from the applicant's immediate supervisor, and one from a teacher, preferably from the school assigned, or an Association representative.

Applications submitted shall be subject to a screening process determined by the Joint Panel to ensure that the candidate meets the established qualifications. All materials submitted to the Joint Panel are confidential.

There will be one (1) formal interview of the candidate with all Joint Panel members and one (1) unannounced classroom observation by a teacher and administrator who are Joint Panel members.

B. **Selection Criteria** – The Consulting Teacher shall have permanent status in the District and possess a clear California teaching credential; shall have substantial recent teaching experience; demonstrate exemplary teaching ability; demonstrate effective oral and written communication; demonstrate leadership ability within the profession; demonstrate ability to work cooperatively and effectively with other staff members; possess extensive knowledge of subject matter and mastery of a range of teaching strategies and instructional/classroom management techniques.

C. **Duties and Responsibilities** – Consulting Teachers shall assist Participating Teachers through demonstrations, observations, coaching, recommending conferences and/or staff development activities. A cooperative relationship is strongly encouraged between the Consulting Teacher and Site Administrator with respect to the process of Peer Assistance and Review.

Consulting Teachers shall:

- Meet with the Referred Teacher and the Site Administrator to discuss the Peer Assistance and Review Program, and to establish mutually agreed upon performance goals with respect to the process of Peer Assistance and Review;
- Meet with the Referred Teacher to develop the assistance plan and the process for determining the successful completion of the Peer Assistance and Review Program;
- Conduct multiple observations of the Referred Teacher during classroom instruction;
- Conduct pre and post observation conferences which provide specific immediate feedback;
- Meet regularly for observations/discussions with each Referred Teacher assigned;
- Conduct model lessons, staff development, and seek appropriate resources as needed;
- Maintain a comprehensive written log of contacts and specific support given to each Referred Teacher assigned;
- Document all observations, visitations, and meetings;

- Report activities on a regular basis to the Joint Panel;
- Monitor the progress of the Referred Teacher;
- Submit periodic reports to Referred Teacher assigned and discuss, in depth, their contents;
- Provide at any time, but at least quarterly, a written report to the Joint Panel regarding the progress of the Referred Teacher;
- Submit final report to the Referred Teacher for his/her signature to verify delivery and receipt;
- Submit final report to the Joint Panel by April 15;
- Participate in an annual review of the Program with the Joint Panel;
- Participate in meetings with other District Consulting Teachers.

D. **Reassignment Request** – The Consulting Teacher shall have the right to present reasons in writing why the Referred Teacher should be reassigned to another Consulting Teacher and to have those reasons considered by the Joint Panel. The Joint Panel may seek follow-up information in regards to this request.

E. **Length of Term** – The length of term for a Consulting Teacher shall be one (1) year with annual performance reviews by the Joint Panel. Based upon the need of the Referred Teachers and the performance of the Consulting Teacher, a Consulting Teacher may be re-appointed for another year, up to a maximum of three (3) consecutive years. Upon completion of one (1) year of service, he/she has the right to return to the work site where he/she worked prior to becoming a Consulting Teacher.

5. **Joint Panel** – The Joint Panel will supervise and evaluate the PAR Program and shall consist of seven (7) members composed of four (4) permanent certificated classroom teachers selected by the Association, and three (3) administrators selected by the District.

A. **Term of Office**

1. Both Association and District Joint Panel committee members shall serve one three (3) year term. Joint Panel members may be re-appointed and serve another three (3) year term only after a one (1) year hiatus from service as a panel member.
2. During the first year of the Peer Assistance and Review Program, the term of office for Association and District members of the panel shall be as follows:

**Association:**

- Two (2) Joint Panel members shall serve three (3) years;
- One (1) Joint Panel member shall serve two (2) years;
- One (1) Joint Panel member shall serve one (1) year (may be re-appointed to a one three (3) year term)

**District:**

- One (1) Joint Panel member shall serve three (3) years;
- One (1) Joint panel member shall serve two (2) years;
- One (1) Joint Panel member shall serve one (1) year (may be re-appointed to a one three (3) year term)

3. In subsequent years, the term of office for Association and District members of the panel shall be rotating as follows:

**Association:**

- Two (2) new Joint Panel members in year one;
- One (1) new Joint Panel member in year two;
- One (1) new Joint Panel member in year three.

**District:**

- One (1) new Joint Panel member each year.

B. **Vacancies** – The Association and the District are responsible to re-appoint and fill a vacancy, which may occur during the year for any of their respective members. Joint Panel members who serve less than eighteen (18) months may be re-appointed to another term. Joint Panel members who serve more than eighteen (18) months on the committee, may not be re-appointed to another term without a one (1) year hiatus.

C. **Duties**

- Administer the PAR Program
- Act as Liaison to the Office of K-6 and 7-12 Instruction;
- Select Consulting Teachers
- Provide for training for Consulting Teachers
- Establish the number of Participating Teachers assigned to each Consulting Teacher annually;
- Assign Consulting Teachers to Participating Teachers
- Evaluate Consulting Teachers and their documentation;
- Monitor the activities of the Consulting Teachers to ensure that sustained assistance is provided to the Referred Teachers;
- Monitor the progress of the Referred Teachers;
- Meet at least quarterly with Consulting Teacher;
- Determine number of voluntary participants and their needs annually;
- Evaluate PAR annually in order to improve the program and report findings to the Board of Education and the Association;
- Develop a PAR budget annually for Board of Education approval.


D. **Operational Procedures** – The Joint Panel will work under the following guidelines:

- Five (5) constitutes Quorum and a Majority Vote;
- Meeting schedule will be developed annually;
- Joint Panel Chair and Vice-Chairperson selected annually;
- Clerical assistance provided;
- Annually determine training needs for Joint Panel members;
- Establish procedures when conflict of interest or bias occurs among Joint Panel and Consulting Teachers;
- Establish a model for decision making;
- Establish procedures for confidentiality;
- Establish appeal procedures for Referred Teachers regarding replacement of the Consulting Teacher, and disagreement with any or all parts of their Consulting Teacher's documentation;
- Determine when Rules and Procedures shall be distributed to certificated employees of the District;
- Annually develop and review timelines and forms

D. **Report to Board of Education** – At the end of the Assistance Program, the Joint Panel shall make recommendations to the Board of Education regarding participants in the Program, including forwarding to the Board of Education the names of individuals who, after sustained assistance, are not able to demonstrate satisfactory improvement.

6. **Special Provisions**

- A. **Confidentiality** – All materials related to evaluations, reports, deliberations, and other personnel matters shall be confidential, subject to the following exceptions:
1. In response to subpoena or order of the court;
  2. The final report of a Referred Teacher's participation in the program shall be made available for placement in his/her personnel file;
  3. The final report may be used by the District in any employment action based upon instructional performance.
- B. **Duty to Indemnify** – The District shall hold harmless the members of the Joint Panel and the Consulting Teachers for any or all liability arising out of their participation in the PAR Program.
- C. **Duties and Responsibilities** – Duties performed pursuant to this Program by bargaining unit members shall not constitute either management or supervisory functions.
- D. **Funding** – Not more than 5% of the funds received by the District for PAR may be expended for administration costs. It is understood and agreed that this Program shall terminate if for any reason there exists an inability for full funding thereof through AB1X or successor legislation.
- E. **Compensation**
- Consulting Teacher/Mentor Teacher – Annual rate of \$4800
  - Joint Panel – Annual rate of \$1500

**Revision to Article 4.5 Case Management Period for 9-12 Ed Specialists in M/S and STRIVE Programs**

With the addition of the following agreed upon new language in Article 4.5n Case Management Period during the 2023-2024 negotiations process:

*"9-12 Education Specialists M/M shall be provided one daily Case Management Period for the purpose of providing student support, preparing IEP documents and other required paperwork, and collaborating with staff,"*

and the inadvertent removal of the last sentence of the prior contract language in 4.5d,

*"All educational Specialists teachers in grades 9-12 shall receive three release days per year,"*

GGUSD and GGEA recognized that language needed to be amended for clarification.

It was not the intention of GGUSD nor GGEA to add a case management period for 9-12 Ed Specialists in the STRIVE program, nor was it the intention to remove the three release days for 9-12 M/S and STRIVE teachers.

Therefore, beginning the 2024-2025 school year:

- 9-12 M/M Education Specialists, not including Ed Specialists in the STRIVE program, shall be provided one daily Case Management Period for the purpose of providing student support, preparing IEP documents and other required paperwork, and collaborating with staff.
- 9-12 M/S teachers will receive three release days to be scheduled by the Personnel Office.
- All Ed Specialists in the STRIVE program will receive three release days to be scheduled by the Personnel Office.

This language will be added to the 2024-2025 Collective Bargaining Agreement as part of the tentative agreement for ratification.
